EV# 16634. ADDRESS OF ARREST 541 N. HARDING. ON TODAY'S DATE, 02 SEPT 15, R/O BURNS WAS WORKING BEAT 6256F ALONG WITH PARTNER OFFICER ALTHOFF IN A MARKED UNIT. R/O BURNS WAS THE PASSENGER WITH OFFICER ALTHOFF BEING THE DRIVER. AT APPROXIMATELY 1950HRS, R/O BURNS AND ALTHOFF OBSERVED A SILVER VEHICLE AND BLACK VEHICLE PARKED ON 538 N. SPRINGFIELD WITH 5 MALE BLACK SUBJECTS STANDING AROUND THE VEHICLES, 1 MALE BLACK SITTING ON THE TRUNK OF THE SILVER CAR, AND IN THE STREET. SAID SUBJECTS WERE IN THE MIDDLE OF THE STREET OBSTRUCTING THE FLOW OF TRAFFIC. R/OS APPROACHED AT WHICH TIME OFFICER ALTHOFF INSTRUCTED THE SUBJECTS TO PUT THEIR HANDS ON THE VEHICLE FOR THE SAFETY OF R/OS AS WELL AS THE SUBJECTS INVOLVED. OEMC NOTIFIED OF STREET STOP AND R/O BURNS REQUESTED AN ADDITIONAL UNIT. R/O BURNS SIMULTANEOUSLY OBSERVED KELLY, CHRISTOPHER STANDING AT THE HOOD OF THE BLACK VEHICLE ON THE RIGHT SIDE IN WHAT APPEARED TO BE A HAND TO HAND TRANSACTION WITH ONE OF THE MALE SUBJECTS. AT THAT TIME OFFENDER KELLY BEGAN TO RUN AWAY FROM R/OS RUNNING NORTH BOUND ON SPRINGFIELD WITH R/O BURNS IN PURSUIT. OFFICER ALTHOFF STAYED BEHIND WITH THE OTHER SUBJECTS WHO WERE DETAINED. R/O BURNS IMMEDIATELY NOTIFIED OEMC CALLING OUT THE DIRECTION OF FLIGHT. OFFENDER KELLY THEN RAN WEST BOUND THROUGH AND INTO THE WEST ALLEY OF SPRINGFIELD AND THEN OUT ONTO OHIO STREET RUNNING WEST BOUND ON OHIO. OFFENDER KELLY THEN RAN BACK SOUTH BOUND ON HARDING AND HEADED EAST INTO A VACANT LOT. R/O BURNS THEN NOTIFIED OEMC THAT UNITS WERE NEEDED



NARRATIVES

IN THE 500 BLOCK OF HARDING WHERE THE SUBJECT WAS LAST SEEN. R/O BURNS THEN HEARD A LOUD NOISE IN THE YARD AT 541 N HARDING AT WHICH TIME R/O BURNS AND ASSISTING OFFICER KEY ENTERED THE YARD TO INVESTIGATE. R/O BURNS AND KEY THEN OBSERVED THAT THE BASEMENT DOOR AT 541 N. HARDING APPEARED TO HAVE BEEN FORCED OPEN AND PULLED FROM THE HINGES OF THE DOOR FRAME. R/O BURNS THEN INVESTIGATED AND OBSERVED OFFENDER KELLY HIDING INSIDE THE STAIRWELL OF THE BASEMENT. R/O ANNOUNCED "POLICE" AND ORDERED THE SUBJECT TO SHOW HIS HANDS. OFFENDER KELLY COMPLIED AT WHICH TIME R/O S BURNS AND KELLY ASSISTED OFFENDER KELLY OUT OF THE STAIRWELL AT WHICH TIME HE WAS PLACED INTO CUSTODY FOR A CRIMINAL TRESPASS AND DAMAGE INVESTIGATION. OFFENDER KELLY WAS THEN HANDED OVER TO OFFICERS WHO ESCORTED THE OFFENDER FOR TRANSPORT. R/O BURNS AND KEY REMAINED ON SCENE SEARCHING THE IMMEDIATE AREA FOR EVIDENCE AND CONTRABAND. P.O. ALTHOFF FURTHER DISCOVERED 1 SEALED MR. BIG SHOT MAUI MADNESS, SUSPECT SYNTHETIC CANNABIS ON THE HOOD OF THE SILVER VEHICLE IN THE SAME LOCATION WHERE OFFENDER KELLY HAD BEEN STANDING UPON FIRST OBSERVATION BY R/O BURNS. R/O ALTHOFF ALSO OBSERVED IN PLAIN VIEW 6 CLEAR, INDIVIDUALLY PACKAGED ZIPLOC BAGGIES CONTAINING A GREEN LEAFY SUBSTANCE, SUSPECT CANNABIS IN THE CENTER CONSOLE OF BLACK VEHICLE. R/O DIEBALL, CONDUCTING A CUSTODIAL SEARCH OF THE BLACK VEHICLE FOUND 1 SEALED MARDI GRAS PREMIUM BLEND PACKAGE CONTAINING SUSPECT SYNTHETIC CANNABIS INSIDE OF THE VEHICLE, ABOVE DRIVER SIDE VISOR, BETWEEN THE ROOF AND CEILING OF VEHICLE. OFFENDER KELLY TRANSPORTED TO NORWEIGAN HOSPITAL BY AMBULANCE 3. SEE ADDITIONAL DETECTIVE REPORT. SEE DEATH INVESTIGATION REPORT UNDER RD# HY408073. SEE ADDITIONAL SUPPLEMENTAL REPORTS.
