EVENT 08739 IN SUMMARY, R/O RECEIVED A CALL OF SHOTS FIRED AT [REDACTED] N. KEDVALE. UPON ARRIVING ON THE SCENE R/O OBSERVED ONE M/B SHOT 5 TIMES. THE VICTIM WAS SHOT 3TIMES IN THE RIGHT THIGH AND 2 TIMES ON THE LEFT THIGH. THE VICTIM RELATED TO R/O THAT HE WAS WALKING NORTHBOUND ON KEDVALE WHEN HE HEARD GUN SHOTS AND BEGAN TO RUN. THE VICTIM OBSERVED A SLIVER SUV FLEEING THE SCENE BUT DID NOT GET A GOOD LOOK AT THE OFFENDER. THE VICTIM WAS SHOT A [REDACTED] N. KEDVALE ON THE SIDEWALK. THE VICTIM WAS ALSO SHOT 4 MONTHS AGO IN THE LEG ON THE SAME STREET. THE VICTIM INDICATED THAT HE WAS NOT GANG AFFILIATED. THE VICTIM WAS TRANSPORTED TO MT. SINAI HOSPITAL BY AMBULANCE #10.
