UPON ARRIVAL R/OS OBSERVED [REDACTED] (VICTIM) WITH AN APPARENT GUN SHOT WOUND TO HIS LEFT FOOT, [REDACTED] (VICTIM) WITH A GUN SHOT WOUND TO RIGHT LOWER LEG AND [REDACTED] (VICTIM) WITH (2) GUN SHOTS WOUNDS TO HIS LEFT LEG.
