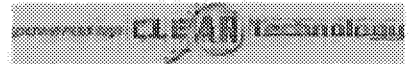

EVENT #16271. R/O'S RESPONDED TO A CALL OF A MENTAL WITH A KNIFE AT THE ABOVE LISTED LOCATION. R/O'S OBSERVED BEAT 1123 ENTERING THE RESIDENCE AND WENT TO COVER THE REAR OF THE LOCATION AT WHICH TIME R/O'S HEARD MULTIPLE SHOTS FIRED FROM INSIDE THE RESIDENCE. R/O'S LATER WOULD SPEAK WITH THE VICTIMS WHO RELATED THAT JAMES ANDERSON(OFFENDER) WAS HOLDING A BOX CUTTER IN EACH HAND UPON ENTRY. P.O. E SEHNER (VICTIM) ATTEMPTED TO DEPLOY HIS TASER ON OFFENDER BUT THIS HAD NO EFFECT. OFFENDER THEN CHARGED P.O. C RAMEY (VICTIM) WITH THE BOX CUTTERS PLACING P.O. RAMEY (VICTIM) IN FEAR OF HIS LIFE AT WHICH TIME HE DISCHARGED HIS FIREARM MULTIPLE TIMES STRIKING THE OFFENDER IN SELF DEFENSE.
