INVESTIGATION: R/D's were assigned to investigate the police involved shooting with no hits which occurred at 5818 S Peoria.

NARRATIVES

R/D's learned that the involved officers had been in a vehicle pursuit which had started on 87th st and ended at the scene of the shooting. R/D's also learned that an offender was in custody.

R/D's relocated to the scene on 58th and Peoria. R/D's spoke with the involved officers who related the following.

PO's Wagner and Garza observed the above listed vehicle being driven by ATWOOD along with a front and rear passenger commit a traffic violation on 87th street and attempted to curb same by activating their emergency equipment. ATWOOD refused to stop and a chase was initiated. During the pursuit the officers alerted OEMC. The officers stated that on two separate occasions during the pursuit ATWOOD intentionally struck their vehicle with his. In addition to the involved officers, several additional marked police vehicles became involved in the pursuit. The officers stated that ATWOOD had struck a CTA bus on 5800 S Racine then continued south on Racine then east on 60th and then north on Peoria where he subsequently hit a tree. As the officers approached ATWOOD'S vehicle, ATWOOD and the front passenger exited the vehicle. P.O. Wagner gave verbal commands to ATWOOD to stop and show his hands. ATWOOD then made furtive motion toward his waist leading Wagner to believe he was armed. P.O. Wagner believing ATWOOD to be armed discharged his weapon one time (no hits) at which time ATWOOD fled south on foot. P.O. Wagner sent a flash of Atwood and a short time later responding units placed ATWOOD into custody.

Bt 5843 arrived on scene. Bt 5843 then processed the scene photographing and recovering anything of evidentiary value. For a complete account refer to the Crime Scene Processing report.

R/D's returned to Area South contacted Felony review. ASA GRAUNKE arrived in Area South and after being appraised of the facts and speaking with involved parties approved Agg. Assault, and Agg. Fleeing charges.
