EVENT #13460:

ABOVE ARRESTED ON SIGNED COMPLAINTS AFTER BEING IDENTIFIED BY VICTIM [REDACTED] VICTIM RELATED THAT AFTER TALKING TO OFFENDER FOR A COUPLE OF HOURS OFFENDER STOOD UP AND YELLED OUT [REDACTED] OFFENDER KICKED VICTIM THEN PUSHED [REDACTED] TO THE GROUND, AS VICTIM GOT OFF THE GROUND OFFENDER THEN BEGAN TO PUNCH VICTIM REPEATEDLY IN THE FACE WITH A CLOSED FIST. VICTIM RELATED THAT [REDACTED] HIT OFFENDER IN THE MOUTH DURING THE PHYSICAL ALTERCATION BECAUSE [REDACTED] WAS IN FEAR OF [REDACTED] LIFE, CAUSING OFFENDER TO BLEED FROM MOUTH. AFTER PHYSICALLY ATTACKING VICTIM OFFENDER FLED SCENE AND KICKED OUT THE DRIVER SIDE WINDOW OF [REDACTED] VEHICLE (WHICH IS A STATE OWNED VEHICLE). A/O'S ARRIVED ON SCENE AND OFFENDER WAS VERY COMBATIVE, A/O'S PERFORMED PROPER TAKEDOWN TECHNIQUES. AS A/O'S WERE TRANSPORTING OFFENDER TO THE WAGON OFFENDER SPIT BLOOD IN ABOVE LISTED VICTIMS FACE BEFORE BEING PLACED IN THE WAGON. OFFENDER WAS STILL COMBATIVE UPON ARRIVAL TO 005TH DISTRICT, A/O'S HAD TO TAKE OFFENDER IMMEDIATELY TO LOCKUP. OFFENDER HAS NO USC ON HIS PERSON.

OFFENDER HAS NO WARRANTS, NO INVESTIGATIVE ALERTS. CLEAR IN GIPP/TRAPP. AMBULANCE #5 ON SCENE TRANSPORTED VICTIMS TO METRO SOUTH, TREATED BY MANCZKO. ALL VICTIMS TREATED AND RELEASED. PER DETECTIVE CONNOLLY #21407 BATTERY CHARGES NOT UPGRADED TO FELONY CHARGE.
