NARRATIVE

EV# 02558 IN SUMMARY PHILLIP COLEMAN(OFFENDER) BECAME AGGRESSIVE TOWARDS OFFICERS IN THE LOCK-UP WHILE BEING TRANSPORTED TO COURT. P.O. FOUCH #19814 DEPLOYED HIS TASER AND OFFENDER WAS THEN TRANSPORTED TO ROSELAND HOSPITAL. WHILE AT THE HOSPITAL PHILLIP COLEMAN(OFFENDER) JUMPED OFF THE GURNEY AND STATED TO OFFICERS "I'M COMING" AND CHARGED AT THEM IN AN AGGRESSIVE MANOR PLACING THEM IN FEAR FOR THEIR SAFETY. P.O. BRIAN HOOD (VICTIM) BEING IN FEAR FOR HIS SAFETY DEPLOYED HIS TASER IN AN ATTEMPT TO RESTRAIN THE OFFENDER. PHILLIP COLEMAN(OFFENDER) JUMPED TO HIS FEET AGAIN AND ATTEMPTED TO DISARM OFFICER BRIAN HOOD (VICTIM) STATING " GIVE ME THAT TASER" AND GRABBED THE RIGHT WRIST OF OFFICER HOOD, TWISTING IT IN THE PROCESS. P.O. DAVID MONTGOMERY (VICTIM AND COMPLAINANT) ALSO BEING IN FEAR OF HIS SAFTY AS WELL AS THE HOSPITAL STAFF UTILIZED HIS BATON IN ATTEMPT TO SUBDUE THE OFFENDER. CEDRICK JORDON (VICTIM) AND BUFORD HART (VICTIM) BOTH C.F.D. AMBULANCE #60 RUSHED TO HELP SUBDUE THE OFFENDER AND WERE BOTH SPAT ON BY OFFENDER. RODRIQUEZ JACKSON (VICTIM) A SECURITY GUARD ALSO CAME TO HELP CONTROL THE SITUATION AND HE WAS SPAT ON BY THE OFFENDER AS WELL. [REDACTED] (WITNESS) A SECURITY GUARD HEARD THE OFFENDER TALKING ABOUT JESUS AND THEN CHARGE THE OFFICERS. [REDACTED] (WITNESS) HEARD THE OFFENDER TALKING ABOUT "GOD" AND THEN TELL THE OFFICERS THAT HE WAS COMING AND THEN CHARGED THE OFFICERS. [REDACTED] (WITNESS) A NURSE AT ROSELAND HOSPITAL STATED SHE SAW THE OFFENDER CHARGE AT THE OFFICERS AND SHE FURTHER STATED "THOSE OFFICERS SAVED THE WHOLE EMERGENCY ROOM". [REDACTED] (WITNESS) AN EMPLOYEE AT ROSELAND HOSPITAL HEARD THE OFFENDER SAY "I'M GOING TO GET YOU" AND THEN CHARGED AT THE OFFICERS. [REDACTED] (WITNESS) SAW THE OFFENDER CHARGE AT THE OFFICERS. OFFENDER WAS TAKEN DOWN AND HELD ON THE FLOOR BY THE FOLLOWING- C.F.D BUFORD HART, C.F.D. CEDRICK JORDON, SECURITY GUARD [REDACTED] P.O. BRIAN BAADER, P.O. RONALD LIS AND SGT. WILLIAM MEADOR (WITNESS) UNTIL THE HOSPITAL STAFF COULD ADMINISTER A SEDATIVE. E.T. COMISKEY # 6082 BEAT 5823 WAS AT THE 005TH DIST TO TAKE PHOTOS OF P.O. MONTOMERY AND P.O. HOOD'S INJURIES.
