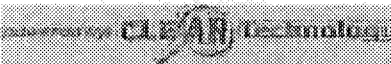

**NARRATIVE**

EVENT#13460 IN SUMMARY RO/S RESPONDED TO A CALL OF DOMESTIC BATTERY. UPON ARRIVAL RO/S WERE MET BY A [REDACTED] RELATED [REDACTED] ELDERLY NEIGHBOR [REDACTED] (VICTIM) HAD BEEN BATTERED BY [REDACTED] PHILLIP COLEMAN(OFFENDER). [REDACTED] (VICTIM) ALSO RELATED THAT AFTER A CALM CONVERSATION WITH [REDACTED] PHILLIP COLEMAN(OFFENDER) HE STOOD UP AND STATED [REDACTED] AT WHICH TIME THE OFFENDER KICKED VICTIM IN THE LEG AND PUSHED [REDACTED] DOWN. PHILLIP COLEMAN(OFFENDER) THEN PUNCHED THE VICTIM IN THE FACE REPEATEDLY CAUSING [REDACTED] TO HAVE A LACERATION ON [REDACTED] FOREHEAD A BLOODY NOSE AND A BLACK LEFT EYE. [REDACTED] (VICTIM) GRABBED A UNKNOWN OBJECT AND HIT OFFENDER IN THE MOUTH CAUSING IT TO BLEED. [REDACTED] (VICTIM) THEN FLED THE SCENE TO SAFETY [REDACTED] PHILLIP COLEMAN(OFFENDER) ALSO FLED THE SCENE. R/O'S WERE THEN APPROACHED BY [REDACTED] (PERSON REPORTING OFFENSE) WHO STATED THAT [REDACTED] WAS GONE CRAZY HE HAD BROKEN OUT THE DRIVER SIDE WINDOW TO [REDACTED] STATE OWNED WORK VEHICLE [REDACTED] AND WANTED POLICE TO TAKE HIM TO GET MEDICAL TREATMENT. PHILLIP COLEMAN(OFFENDER) WAS THEN OBSERVED WALKING ON THE SIDEWALK AT APPROXIMATELY 12828 S. MORGAN TOWARD R/O'S. AS R/O'S APPROACHED PHILLIP COLEMAN(OFFENDER) HE CHARGED AT R/O'S, R/O'S PREFORMED A TAKEDOWN AND PLACED PHILLIP COLEMAN(OFFENDER) IN CUSTODY. PHILLIP COLEMAN(OFFENDER) WHILE IN CUFFS WAS STILL COMBATIVE. AT THE TIME THE OFFENDER WAS BEING PLACES IN THE WAGON BY ALL ASSISTING OFFICERS FOR TRANSPORT TO THE 005TH DISTRICT STATION FOR FURTHER PROCESSING HE BEGAN TO SPIT BLOOD AT OFFICERS STRIKING OFFICER DELISLE JAMES (VICTIM) AND SERGENT SEAN TULLY (VICTIM) IN THE FACE WITH BLOODY SALIVA. [REDACTED] (VICTIM) WAS TRANSPORTED TO METRO SOUTH HOSPITAL BY AMBULANCE 51 DELISLE JAMES (VICTIM), AND SEAN TULLY (VICTIM) WERE TRANSPORTED BY AMBULANCE 5 TO METRO SOUTH HOSPITAL WHERE THEY WERE ALL TREATED AND RELEASED BY DR. [REDACTED] [REDACTED] (PERSON REPORTING OFFENSE) WAS NOT INJURED AND REFUSED REPORT FOR VEHICLE DAMAGE. VIN GIVEN TO VICTIMS.
