event# 06241 above arrested after p.o. montesdeoca and p.o. storck responded to an assault in progress call at 1019 w 103rd pl and found the offender (lumpkin, mekel p) on the sidewalk in front of 1041 w 103rd pl firing a handgun into the occupied house at [redacted] w 103rd pl. p.o. montesdeoca exited his vehicle, drew his weapon, pointed it at the offender, announced his office, and ordered the offender to drop his weapon. the offender did not comply with p.o. montesdeoca's verbal commands, turned in p.o. montesdeoca's direction pointing the handgun at p.o. montesdeoca and p.o. montesdeoca, in fear of death or great bodily harm, fired his weapon and struck the offender. the offender fell to the ground and p.o. montesdeoca placed the offender in custody and p.o. storck immediately requested an ambulance via oemrc. p.o. montesdeoca and p.o. storck secured the arrestee's handgun. the handgun was recovered by f.i. decook and found to be a 9mm handgun with an extended clip. clear in gipp, warrants, and alerts. not on parole or probation.
