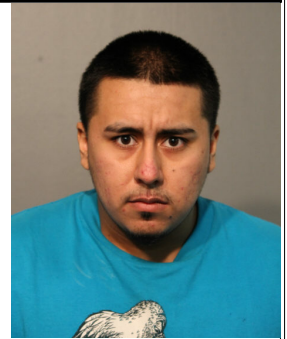

ARREST REPORTING

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event#00932. Above is an on view arrest by BT 1947r and supporting 19th district units. In summary, A/O's responded to an OEMC dispatched call of "Person with a GUN" in the vicinity of 3016 N Clybourn. While responding, A/O's were alerted to BT 1913R calling out "Shots Fired." Upon hearing this, A/O's immediately responded to the respective beat's location and saw the above listed vehicle fleeing N/B from location with PO Kuhlmann#15354 (KNA Witness) pointing towards it alerting A/O's to it being the offending vehicle. A/O's activated emergency equipment in an attempt to curb said vehicle to which it did not comply. The vehicle then proceeded N/B on Western all the while disregarding several traffic signals and committing several IVC infractions (tickets issued: TH-274-772 thru TH-274-774). The said vehicle then attempted to turn E/B on Leland from Western and subsequently crashed into a fence at 2356 W Leland. An UNK M/4 (KNA Valle, Giovanni/Offender), who was the driver and sole occupant of the vehicle, fled from the vehicle and was subsequently placed into custody after a brief foot pursuit. Driver failed to produce a DL and insurance. A/O's then secured offender's vehicle and observed a handgun on the passenger side floor (A/O's secured scene). ET Worthem#12110 BT 5831 arrived on scene to both process it and recover said weapon. Bt 1971R transported offender to 19th district (West) for processing. A/O's conducted a custodial search of said vehicle and found in the trunk (1) large plastic bag containing (2) Glad clear containers each containing suspect cannabis (1) Glad clear container containing narcotics packaging and (2) black digital scales (INV#13599035 AND 13599044). A/O's learned that the driver (KNA Valle, Giovanni) used said vehicle in an attempt to strike PO Weingart#18482 (KNA Victim) with vehicle. Name check clear, no alerts, no id, clear GIPP/TRAPP, 2DA, and SSL. Offender denies gang affiliation and no found via CPD clear system. Investigation handed to Area North Detectives. offender made post Miranda comments regarding handgun and possession of cannabis.
