NARRATIVES

THIS IS AN AREA CENTRAL PROGRESS SUP NARRATIVE

INVESTIGATION:

This report is to be read in conjunction with all over reports generated under Record Division Number HZ-107878 and HZ-107816. This report is a summarization of all reported information and all interviews are also in summary format and are not to be considered verbatim.

On 08 January 2016 the Reporting Detective had received a compact disc containing the recordings of the 911 calls and the Chicago Police radio transmissions. The Chicago Police Department radio transmissions from Zone 13 began at 2224hrs and the transmissions end at 2359hrs.

At 2min 10 sec: Zone 13 dispatched a call of multiple calls of shots fired to Bt 921R in the area of 41st Pl and Albany.

At 3min 06sec: 911R asked Zone 13 to run a plate for him. 911R stated they have a vehicle fleeing from them. 911R described the fleeing vehicle as a white Ford Escape.

At 3min 31sec: 911R radioed they were at 36th and Western Ave driving northbound.

At 3min 44sec: 911R radioed they were still northbound on Western Ave from 35th St.

At 3min 50sec: 911R radioed the white Ford Escape was seen fleeing the area of the shots fired called at 41st and Albany.

At 3min 59sec: 911R radioed that they were at the intersection of Western Ave and Bross.

At 4min 06sec: 911R radioed "shots fired, shots fired"

At 4min 17sec: 911R radioed there was a person in custody.

At 5min 08sec: 911R radioed they have a weapon recovered.

At 5min 17sec: 911R radioed a second offender was seen fleeing eastbound. The second subject was wearing a black hoodie and dark colored jeans. The second subject was heavy set build and may be hiding in the alley.

NARRATIVES

At 6min: 911R radioed the second offender maybe hiding behind 3241 or 3245 S. Claremont Ave.

At 6min 10sec: Zone 13 dispatched there was a person shot in the area of 41st and Albany.

At 8min 06sec: 911R gave a description of the subject that was seen fleeing eastbound. The subject was described standing 6'03" and weighing 280lbs, this subject was one of three people seen fleeing from the white Ford Escape.

At 10min 10sec: 920R radioed the address of the person shot was at 3116 W. 41PI. 920R radioed the person shot was in critical condition.

At 11min 18sec: 933R radioed the person shot was related to the incident at Bross and Claremont.

At 19min 32sec: 925R radioed that one is in custody at 3250 S. Oakley. Second offender that was wearing the black hoodie, medium hair shag light jeans was found by 6712G.

At 20min 43sec: 921R radioed he had additional information shooters in a white truck fled northbound in the west alley of Albany. One of the offenders may be missing his shoe. The subject missing his shoe is in custody.

At 23min 22sec: 911R radioed there was one subject still outstanding. The outstanding subject was a male Hispanic with a height of 5'05"-5'07".

The radio transmissions continued until 2359hrs, but the above listed information contained the pertinent information regarding the Aggravated Assault of Officer CALDERON. The Reporting Detective inventoried the compact disc containing the radio transmissions, under CPD Inventory #13640985.

This investigation remains in progress.
