**NARRATIVES**

EVENT#00246 IN SUMMARY, AOS WERE ON ROUTINE PATROL OF THE 4200 BLOCK OF W CERMAK WHEN THEY OBSERVED A SUBJECT, NKA COOK, DRINKING A CLEAR BEVERAGE FROM A CLEAR CUP(INV#) WHILE HE WAS STANDING ON THE SIDE WALK. AOS KNOWING THIS IS HOW ALCOHOLIC BEVERAGES ARE CONSUMED WHEN SUBJECTS ARE ON THE PUBLIC WAY EXITED THEIR VEHICLE FOR A F/I. AS AO APPROACHED THE OFFENDER TURNED AND STARTED TO FLEE FROM AO EAST BOUND FIRST ON THE SIDEWALK THEN RUNNING ACROSS THE GRASS INTO THE STREET PUTTING AO IN FEAR OF BEING STRUCK BY VEHICLES TRAVELING WEST BOUND ON CERMAK. AO REPEATEDLY ORDERED THE OFFENDER TO STOP BUT THE OFFENDER IGNORED AOS COMMANDS AT WHICH TIME AO OBSERVED THE OFFENDER THROW WHITE NAPKIN TO THE GROUND ALONG WITH A CLEAR GLASS BOTTLE OF AN ALCOHOLIC BEVERAGE IN THE OFFENDERS REAR RIGHT PANTS POCKET (INV#13527160). OFFENDER CONTINUED TO FLEE EAST BOUND IN THE STREET HOLDING HIS SIDE IGNORING AOS ORDERS TO STOP, IN WHICH ATTEMPTING TO DEFEAT THE ARREST. DUE TO THIS AND OFFENDER HOLDING HIS SIDE AS IF HE COULD BE ARMED, AO DEPLOYED HIS TASER STRIKING THE OFFENDER IN THE BACK CAUSING THE OFFENDER TO FALL TO THE GROUND. AOS WERE ATTEMPTING TO HANDCUFF THE OFFENDER WHEN A CROWD BEGIN TO FORM YELLING AT AO AND APPROACHING THEM. AT THIS TIME A MALE BLACK SUBJECT, NKA BRANDON DERRICK, WALKED UP TO AOS GRABBING THE BOTTLE OF ALCOHOLIC BEVERAGE THAT WAS IN THE OFFENDERS REAR PANTS POCKET WHICH HAD FALLEN NEXT TO HIM. AO ZAYAS #10661 ORDERED THE OFFENDER TO STOP AND TO GET BACK OR HE WAS GOING TO BE ARRESTED, BUT THE OFFENDER FLED EAST BOUND ACROSS THE GRASS THROUGH THE MIDDLE OF THE HOSTILE CROWD THAT HAD GATHERED. AO ZAYAS #10661 GAVE CHASE ORDERING THE OFFENDER TO STOP OR HE WAS GOING TO GET TASED BUT HE CONTINUED TO FLEE IGNORING AOS ORDERS AND WARNING. OFFENDER ACTIONS OF ATTEMPTING TO DEFEAT THE ARREST CAUSED AO ZAYAS #10661 TO DEPLOY HIS TASER STRIKING THE OFFENDER IN HIS BACK CAUSING HIM TO FALL AT WHICH TIME HE WAS TAKEN INTO CUSTODY. AO ZAYAS #10661 WENT TO THE AREA WHERE OFFENDER COOK TOSSED THE WHITE NAPKIN DISCOVERING IT TO CONTAIN A CLEAR ZIP LOCK BAGGIE CONTAINING A CRUSHED GREEN LEAF LIKE SUBSTANCE SUSPECT CANNABIS (INV#13527173. AMBULANCE #67 ARRIVED ON SCENE TREATING BOTH OFFENDERS ON SCENE. OFFENDER COOK WAS TRANSPORTED TO MT SINI FOR TREATMENT TO LACERATIONS TO HIS FACE WHICH HE RECEIVED AFTER HE FELL TO THE GROUND WHEN BEING TASED. OFFENDER BRANDON WAS TRANSPORTED TO 010 FOR PROCESSING. OFFENDER COOK HAS ID, \$183 USC, IS A MEMBER OF THE GANGSTER DISCIPLE STREET GANG, NAME CHECK, GIPP, TRAPP, SSL CLEAR. TASER CARTRIDGE INV#13527162. COOK WAS TREATED AND RELEASED BY DR FURGESON AT MT SINI HOSPITAL FOR MINOR LACERATIONS TO HIS FACE. PERSONAL PROPERTY INV#13527168 AND 72. CLEAR PLASTIC CUP ALONG WITH A PICTURE OF THE GLASS BOTTLE OF TEQUILA WAS INVENTORIED UNDER #13527160 OFFENDER BRANDON HAS ID, \$140 USC, ADMITS TO BEING A MEMBER IF THE BLACK GANGSTER STREET GANG, NAME CHECK, GIPP, TRAP, SSL CLEAR. TASER CARTRIDGE INV#13527175. PERSONAL PROPERTY INV#13527177 ET BEAT 5815 KRUPA #13324 TOOK PICTURES OF BOTH OFFENDERS INJURIES
