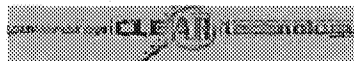

INVESTIGATION:

R/Ds were assigned to investigate a police related shooting and proceeded immediately to the scene, located at 7055 S. Merrill Avenue. R/Ds arrived to find the scene protected by 3rd District personnel and units from 211. The scene was taped off with yellow and red crime scene tape. R/Ds learned that an armed offender had been shot by a police officer when he pointed a handgun at the officer. The offender was transported to Northwestern Memorial Hospital in critical condition prior to the R/Ds arrival on scene. A semi automatic pistol, dropped by the offender, was located at the scene of the shooting. No officers were injured in the incident.

Command staff, and senior officers from units 211, 003, 610 as well as the 1st Deputy Superintendent were on scene. Representatives from FOP and IPRA were also present.

Four evidence technicians were on hand to process the scene and recover the physical evidence.

The area of 71st and Merrill Avenue is mixed commercial and residential. 71st Street is a major arterial street running two lanes east and west. The lanes are divided by ground level Metra tracks. The buildings along 71st Street are primarily commercial. These were closed for business. The buildings along Merrill Avenue are multi unit apartment buildings. Several of these were abandoned.

No CPD Pods are in the immediate vicinity. A POD is located several blocks west at 71st and Jeffery Avenue. had visible security cameras at the front, back and side walls. R/Ds made arrangements to retrieve all possible video.

R/Ds examined the crime scene. The scene consisted of five 40 caliber (officers) shell casings on the sidewalk. A 45 caliber Olive/Black semiautomatic pistol lay on the ground at approximately 7055 S. Merrill. A parked car on the east curb at this location had fresh gunshot damage to the passenger side door by the sideview mirror. A large pool of blood was observed in front of this car in the street. This is where the victim fell and where he was taken into custody.

R/Ds learned that several officers and two civilians were witnesses to the incident.

R/Ds canvassed the area but no additional eye-witnesses were located.

Assisting detectives went to Northwestern Memorial Hospital and learned that the offender sustained multiple GSW to the buttocks and groin area. He was in critical condition and was being prepared for surgery. He could not be interviewed. His clothing and belongings were retained as evidence. The offenders family members were at the hospital and notified of his condition.

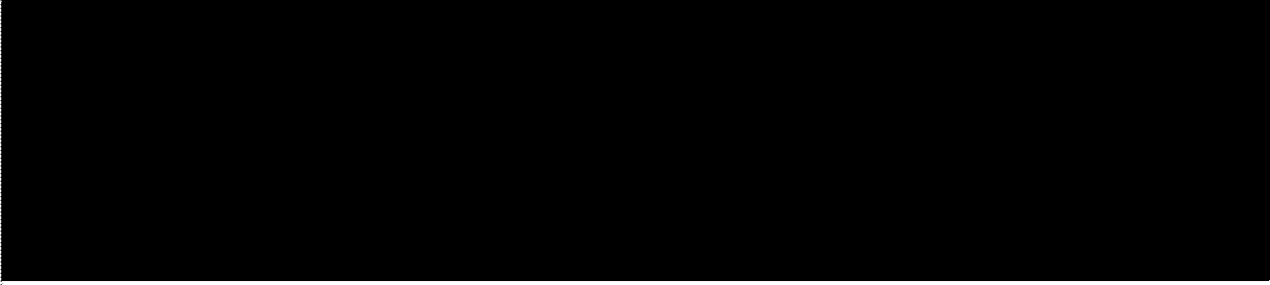
R/Ds interviewed P.O. Babicz. He relate that he and his team (Area Central Gun team) received information that the offender "Nunu" (known to be Alfontish COCKERHAM, was armed with a green and black semiautomatic pistol. The officers proceeded to 71st and Merrill where they observed COCKERHAM walking south on the east side of Merrill. P.O. Babicz exited his squad car to make a street stop. His partner, P.O. Homer, drove to the north alley of 71st to block any escape. When P.O. Babicz approached the four M/B, COCKERHAM fled, running south to the corner and then east on the north side of 71st Street. P.O. Babicz chased him on foot. Sgt. Kinnane and P.O's Vidljnovic and Montoya were driving west on 71st. They observed the offender, who upon seeing them, turned around, fled back past P.O., Babicz. The offender was holding a pistol in his right hand as he ran. He turned the corner again chased by P.O. Babicz. When P.O. Babicz turned the corner, the offender turned toward him, raising the handgun at the officer. P.O. Babicz in fear of his own and others' lives fired five shots at the offender striking him in the buttocks and groin. COCKERHAM dropped his pistol and fell between two parked cars. He was immediately taken into custody and emergency medical attention for him was requested. The officers protected the scene, and secured the witnesses who agreed to cooperate in the investigation.

R/Ds interviewed the other officers separately and individually. Sgt. Kinnane and the others corroborated P.O. Babicz's account of the incident. R/Ds and command staff walked through the scene with the officer. P.O. Vidljnovic observed COCKERHAM fleeing with a gun in his hand.

R/Ds proceeded to Area Central in furtherance of this investigation. Evidence Technicians and Sgt. From IAD were present to administer tests to P.O. Babicz and to recover his weapon.

A.S.A. Hughes of the Cook County States Attorneys Office was present to interview the involved officer, the witness officers as well as [REDACTED]

R/Ds contacted the manager of the [REDACTED] and met with [REDACTED] allowed the R/Ds to recover video footage from the stores security cameras. This footage was viewed and was seen to substantiate the officers and witnesses accounts of the incident.

The offender COCKERHAM remains in critical condition at Northwestern memorial Hospital as of this report. He has not been able to be interviewed.

A.S.A. Hughes made this a continuing investigation until COCKERHAM can be interviewed. She also requested that the R/Ds locate and interview [REDACTED] who told Chicago Tribune Reports [REDACTED] witnessed the shooting. As of this report [REDACTED] has not been located.

This investigation continues.
