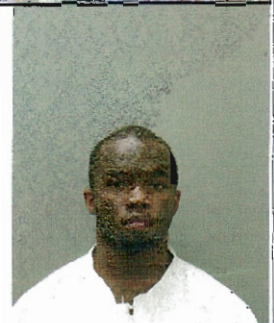

VICTIM IS A POLICE OFFICER WHO FIRED HIS WEAPON IN SELF DEFENSE AFTER HE WAS SHOT. THE VICTIM SUSTAINED A GUNSHOT WOUND TO THE LEFT BUTTOCKS EXITING HIS RIGHT FRONT HIP.
