(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

INCIDENT NARRATIVE

Event #09652. In Summary, the above placed into custody in that as the A/Os were attempting to conduct a narcotics related investigation on the Arrestee, now known as Shaquille O'Neal, he grabbed at his waistband and fled on foot. The A/Os gave chase of the Arrestee and gave him numerous verbal commands to stop fleeing. The A/Os chased the Arrestee across Roosevelt Rd observing vehicles stop suddenly and swerve to avoid striking the Arrestee and pursuing officer. As A/O Pratscher chased the Arrestee through a gangway at approximately 3927 W Grenshaw the Arrestee fled through a wrought iron gate, turned and violently slammed gate on the pursuing officer, striking the right side of the A/O's body. The A/O was able to conduct an emergency takedown by pulling the Arrestee down by his shirt. The Arrestee then began to resist by flailing his arms and refusing to comply with the A/O's verbal commands. The Arrestee then began to strike the A/O with a closed fist about the body as he was attempting to remove an item from his pocket. The Arrestee then called out to a group of people near the A/Os to help him fight off the A/Os. The Arrestee was observed making a throwing motion with his right hand. The A/O observed several pink tinted zip lock bags containing a white powdery substance fall to the ground near the Arrestee. The A/O was able to gain control of the Arrestee's right hand and place a handcuff on it before the Arrestee flailed his arms and was able to get both hands under his body. A/O Pratscher grabbed the Arrestee's hand from under his body at which point the Arrestee bit A/O Pratscher's right ring finger, puncturing both sides of the finger. The Arrestee was able to turn his body around and grab A/O Pratscher by the neck, squeezing forcefully. A/O Rosen heard A/O Pratscher struggling and requesting assistance. A/O Rosen delivered a leg strike to the Arrestee which was successful in freeing the Arrestee's grip from A/O Pratscher's throat. The A/Os with the help of assisting Officers were able to gain control of and place the Arrestee into custody. During struggle to place Arrestee into custody AO Rosen#11430 sustained injuries to his knee while struggling to place Arrestee into custody. A/O Rosen was directed by A/O Pratscher to the (3) bags Arrestee threw to the ground and A/O Rosen recovered (3) pink tinted zip lock bags containing a white powdery substance he suspected was heroin (Inv#13706738) as well as a blue latex glove arrestee had removed from his pocket, which contained (1) pink tinted zip lock bag containing a white powdery substance he suspected was heroin (Inv#13706741). The A/Os requested a CFD Ambulance for the Arrestee. CFD AMB #67 arrived and transported the Arrestee to Mt. Sinai. The arrestee was treated by Dr. Singh and was admitted for observation into the Medical Step-down unit due to his Altered Mental State. A/O Pratscher was transported to Rush Hospital and was treated and released by Dr. Patel for a puncture bite wound, soreness to his neck, and numerous cuts and abrasions to his body. The Arrestee name check revealed him to be on Parole and per IDOC a warrant is pending. The Arrestee is clear GIPP/TRAP SSL score 246. The Arrestee is documented member of the Traveling Vice Lord street gang. The Arrestee has \$25.00 U.S.C. on his person. Personal Property Inv#13706764.
