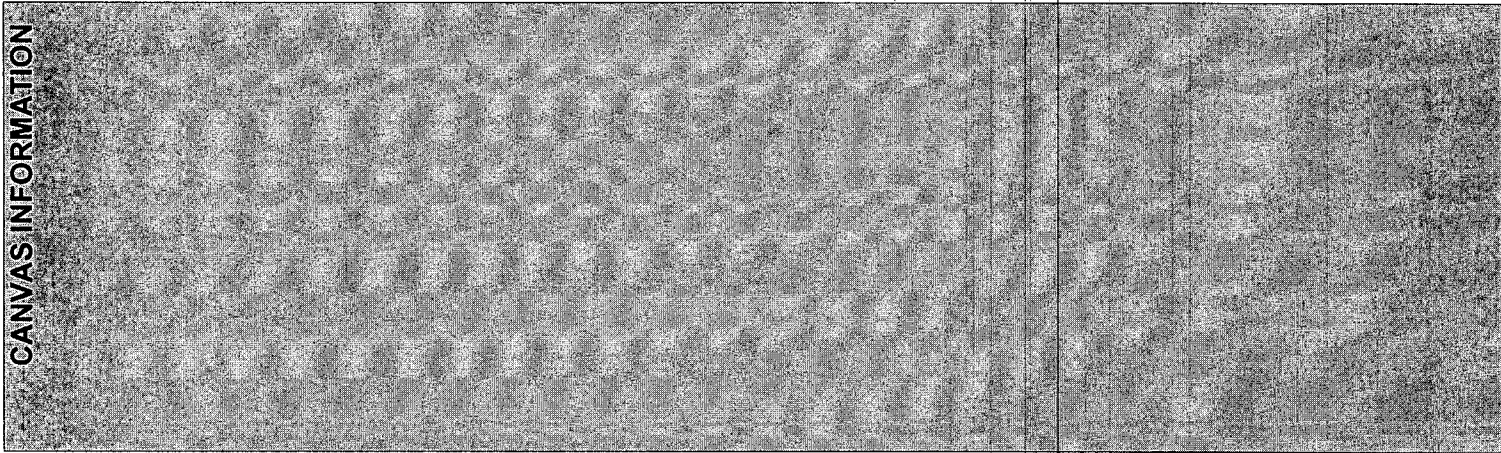

EVENT #16324. IN SUMMARY, R/O'S CURBED VEHICLE FOR MINOR TRAFFIC INFRACTION AT 7850 S. KEDZIE. AS R/O'S APPROACHED, ABOVE OFFENDER WAS OBSERVED LEANING OVER FROM THE PASSENGER SEAT AND PRESSING THE GAS PEDAL WITH HIS LEFT HAND AND ATTEMPTING TO PLACE THE GEAR SHIFTER INTO DRIVE, FAILING TO COMPLY WITH NUMEROUS COMMANDS BY R/O'S TO STOP GRABBING THE GAS PEDAL/GEAR SHIFTER. THE DRIVER OF THE VEHICLE, VICTIM [REDACTED] WAS ATTEMPTING TO STOP OFFENDER JACKSON BUT OFFENDER JACKSON WAS SCREAMING, "DRIVE BITCH, DON'T MAKE ME HIT YOU!" AND WAS ABLE TO GET THE VEHICLE INTO DRIVE. VEHICLE FLED W/B ON 79TH STREET BEFORE COMING TO A STOP AT 7855 S. CENTRAL PARK WHERE OFFENDER BRIEFLY FLED FROM VEHICLE, IGNORING R/O'S VERBAL COMMANDS TO STOP BEFORE FALLING TO THE GROUND AFTER APPROXIMATELY 10 FEET AND STATING HE BROKE HIS LEG. OFFENDER WAS PLACED INTO CUSTODY AND READ RIGHTS. POST MIRANDA, OFFENDER STATED HE FORCED [REDACTED] TO FLEE BECAUSE HE HAS A DOMESTIC WARRANT AND THAT HE HAD BEEN DRINKING AND "FUCKED UP". A NAMECHECK OF OFFENDER REVEALED AN ACTIVE WARRANT (LEADS #W15D3133, CONFIRMED VIA JORDAN #117). VICTIM [REDACTED] STATED ON SCENE THAT SHE ATTEMPTED TO STOP FOR R/O'S MULTIPLE TIMES BUT FEARED FOR HER SAFETY FROM OFFENDER [REDACTED] AFTER THE CAR WAS PUT IN DRIVE. OFFENDER JACKSON TRANSPORTED TO HOLY CROSS HOSPITAL BY CFD AMBULANCE #18. OFFENDER STATED TO ER PHYSICIAN ASSISTANT JAMIE GRUZLEWSKI AT 0025 HRS ON 18-MAR-2015, IN THE PRESENCE OF SGT POPPISH, THAT THE INJURY TO HIS LEG OCCURED WHEN HE WAS RUNNING AND FELL. NAMECHECK VERIFIED WARRANT. NO INVESTIGATIVE ALERTS. OFFENDER NOT ON GIPP/TRAPP/2 DEGREES. OFFENDER IS A GANGSTER DISCIPLE.
