NARRATIVES	<p>EVENT#09652 IN SUMMARY 1063A WHILE ON A NARCOTICS INVESTIGATION IN AN AREA OF HIGH NARCOTIC SALES AND HIGH CRIME, OBSERVED SHAQUILLE ONEAL(OFFENDER) RIDING HIS BICYCLE NORTHBOUND ON SPRINGFIELD AVE (MIDDLE OF THE STREET AT APPROX 1204 S SPRINGFIELD), FOLLOWED BY AN OLDER M/4 AND M/1 (IN STREET). UPON SEEING TACTICAL OFFICERS DRIVE BY, HE QUICKLY SEPARATED HIMSELF FROM THAT GROUP AND HOPPED OFF HIS BICYCLE. OFFICERS MADE A U-TURN TO CONDUCT A NARCOTICS RELATED INVESTIGATORY STOP ON THAT INDIVIDUAL. OFFICERS OBSERVED HIM WALKING WEST BOUND ON ROOSEVELT , OFFENDER THEN PROCEEDED TO PICK UP HIS PACE AS HE OBSERVED BEAT 1063A. OFFENDER THEN PROCEEDED TO RUN WESTBOUND, WHILE GRABBING AT AN ITEM IN HIS RIGHT POCKET. OFFENDER THEN FLED SOUTH BOUND ON HARDING AVE GRABBING AT HIS WAIST AND ATTEMPTING TO REMOVE AN ITEM IN HIS POCKET. OFFENDER THEN BENT DOWN BY A PARKED VEHICLE AND ATTEMPTED TO ELUDE PURSUING OFFICERS. OFFICERS EXITED THEIR VEHICLE AND ANNOUNCED THEIR OFFICE, AT WHICH POINT OFFENDER TURNED AND FLED NORTH BOUND ON SIDEWALK AND THEN ACROSS ROOSEVELT RD, CAUSING SEVERAL VEHICLES TO SWERVE AND STOP TO AVIOD STRIKING OFFENDER AND PURSUING OFFICER. OFFICER PRATSCHER GAVE CHASE AND CONTINUED TO GIVE VERBAL COMMANDS TO STOP, WHICH OFFENDER IGNORED. OFFENDER THEN FLED WESTBOUND THROUGH THE ALLEY STILL ATTEMPTING TO GRAB AN ITEM IN HIS POCKET. OFFENDER THEN FLED INTO A YARD AT APPROX. 3927 W GRENSHAW. P.O. TERRENCE PRATSCHER (VICTIM AND COMPLAINANT) WAS IN PURSUIT OF THE OFFENDER. ONCE THE OFFENDER EXITED THE YARD OF THE 3927 W GRENSHAW OFFENDER SLAMMED THE IRON GATE ON P.O. PRATSCHER'S RIGHT ARM/SHOULDER. P.O. PRATSCHER WAS ABLE TO PERFORM AN EMERGENCY TAKEDOWN AT 3927 W. GRENSHAW BY PULLING AT OFFENDERS SHIRT. AS P.O. PRATSCHER WAS TRYING TO GAIN CONTROL OF THE OFFENDER BY THE HANDS TO DETAIN THE OFFENDER, SHAQUILLE ONEAL(OFFENDER) BECAME AN ASSAILANT BY PUNCHING P.O. PRATSCHER WITH A CLOSED FIST ABOUT THE BODY. OFFICER PRATSCHER RELATED THAT WHILE STRUGGLING ON THE GROUND, OFFENDER BEGAN TO YELL TO A NEARBY GROUP OF INDIVIDUALS "YO! YO! HEY HELP ME, FUCK THIS NIGGA UP, GET HIS ASS". OFFENDER WAS THEN OBSERVED BY OFFICER PRATSCHER MAKING A THROWING MOTION WITH HIS RIGHT HAND, AND OBSERVED SEVERAL SMALL PINK TINTED ZIP LOCK BAGS FALL TO THE GROUND NEAR OFFICER AND OFFENDER. OFFENDER CONTINUED TO YELL TOWARD GROUP ASKING THEM TO COME AND GRAB THE NARCOTICS. OFFICER PRATSCHER RELATED THAT A GROUP OF APPROX 30 INDIVIDUALS BEGAN TO RUN TOWARD HIM AND OFFENDER, ADVANCING ON HIM. OFFICER PRATSCHER RELATED THAT HE FELT THREATENED AND WAS AFRIAD FOR HIS SAFETY BECAUSE GROUP WAS ADVANCING ON HIM AND THEY APPEARED TO KNOW OFFENDER AND WERE YELLING THREATS TOWARD HIM. P.O. ROSEN THEN ARRIVED ON SCENE AND OBSERVED SHAQUILLE</p>

ONEAL(OFFENDER) AND OFFICER PRATSCHER WRESTLING ON THE GROUND. OFFICER PRATSCHER RELATED THAT HE WAS ABLE TO GAIN CONTROL OF ONE HAND AT THIS TIME AND PLACE A HANDCUFF ONTO HIS RIGHT HAND. OFFENDER THEN PULLED AWAY, PULLING HIS HANDS UNDER HIS BODY. AS PO PRATSCHER REGAINED CONTROL OF OFFENDERS HANDCUFFED HAND, OFFENDER BIT ONTO OFFICER PRATSCHERS' FINGER, PUNCTURING THE SKIN ON BOTH SIDES. OFFENDER WAS THEN ABLE TO ROLL OVER ONTO HIS BACK. OFFENDER THEN GRABBED OFFICER PRATSCHER BY THE THROAT AND BEGUN TO CHOKE OFFICER PRATSCHER. OFFICER ROSEN RELATED THAT HE HEARD OFFICER PRATSCHERS' VOICE AND IT SOUNDED LIKE HE WAS STRUGGLING TO SPEAK AND OBSERVED OFFENDER CHOKING OFFICER PRATSCHER WITH HIS FREE HAND. P.O. ROSEN WENT TO HELP HIS PARTNER, DELIVERING A KICK TO THE ASSAILANT. KICK WAS SUCCESSFUL, IN THAT OFFENDER WAS STUNNED AND FREED HIS GRIP ON OFFICER PRATSCHERS THROAT. OFFENDER CONTINUED TO RESIST BY PULLING HIS ARMS AWAY IN AN ATTEMPT TO AVOID CONTROL. OFFICERS WERE FINALLY ABLE TO GAIN CONTROL OF OFFENDER WITH HELP OF ASSISTING UNITS. P.O. ROSEN CALLED A 10-1 TO GET IMMEDIATE ASSIST AS A LARGE CROWD OF AGITATED PEOPLE WERE APPROACHING THEM AND HE FEARED FOR HIS SAFETY AND THAT OF HIS PARTNER IN THAT GROUP WAS AGITATED AND ANGERED. OFFENDER WAS PLACED UNDER ARREST AND AN AMBULANCE WAS CALLED FOR HIM. P.O. ROSEN RECOVERED FROM THE GROUND AT THE OFFENDER'S WAIST AREA A BLUE PLASTIC GLOVE THAT CONTAINED ONE PINK BAGGIE AND THREE OTHER PINK BAGGIES ON THE GROUND NEAR TO THE OFFENDER, FOR A TOTAL OF FOUR PINK BAGGIES CONTAINING A WHITE SUBSTANCE SUSPECT HEROIN (INV# 13706738, 13706741). AMBULANCE 64 RESPONDED AND TRANSPORTED THE OFFENDER TO MT SINAI HOSPITAL. P.O. PRATSCHER WAS TAKEN TO RUSH HOSPITAL FOR A LACERATION TO HIS RIGHT HAND AND SCRAPES TO HIS FOREARMS, PUNCTURE WOUNDS TO HIS FINGER, SORENESS TO HIS NECK AREA AND SHOULDER PAIN BY AMBULANCE #33. OFFICER PRATSCHER WAS SEEN BY DR PATEL AND WAS TREATED AND RELEASED. BEAT 1099 LT. LEIBAS #310 WAS NOTIFIED, BEAT 1001 SGT ORTIZ #2385 NOTIFIED, DET. ORTMAN #20766 BEAT 5305A NOTIFIED, P.O. SANDERS #10507 CPIC NOTIFIED, ET NOTIFIED. OFFICERS RESPONDED THAT RESPONDED ON SCENE FOR THE 10-1 BEAT 1100, 1133,1063, 1163E, 1163, 1171, 1021, 1123, 1125, 1163B, 1163A, 1131, 1060, 1063D, 1163D, 1063C. SHAQUILLE ONEAL(OFFENDER) IS A KNOWN MEMBER OF THE TRAVELING VICE LORD AND IS ON PAROLE FOR NARCOTICS, IDOC #M35111. IDOC SELINA NOTIFIED AT 1845HRS TRACER#112715212. 011 DISTRICT TOOK WALKER KEITH CB#19326771, HZ-305839 IN TO CUSTODY AFTER HE WAS OBSTRUCTING AND BATTERED TWO P.O.'S ON SCENE. DET. LEGLER #20939 BEAT 5332 ON SCENE IN 010 AT 1855HRS. BOTH PO'S ON 1063A SUBMITTED TRR'S BUT THERE WAS AN ERROR ON THE SYSTEM THAT ONCE SUBMITTED IT CHANGED AND CHECKED BOXES ON THE TRR'S, FOUR DATA WAS MADE AWARE AND A TICKET WAS GENERATED #45847343. OFFENDER WAS SEEN BY DR FARRAR AT MT SINAI AND FOUND IN STABLE CONDITION.
