NARRATIVES

EVENT#12185 IN SUMMARY: R/O'S RESPONDED TO A BURGLARY IN PROGRESS AT THE ABOVE LOCATION. UPON ARRIVAL R/O'S WERE APPROACHED BY [REDACTED] (WITNESS) WHO RELATED SHE OBSERVED THE OFFENDER NOW KNOWN AS WALTER GUNN (OFFENDER) BREAK THE REAR KITCHEN WINDOW AND ENTER THE APARTMENT LOCATED AT THE ABOVE LOCATION. [REDACTED] (WITNESS) FEARED THAT THE ABOVE OFFENDER WOULD HARM THE RESIDENT [REDACTED] (VICTIM). AS R/O'S APPROACHED THE FRONT DOOR WALTER GUNN (OFFENDER) EXITED THE APARTMENT HOLDING A METAL POLE AND WOODEN STICK. P.O JACKSON GAVE WALTER GUNN (OFFENDER) VERBAL COMMANDS TO DROP BOTH OF THE WEAPONS. OFFENDER REFUSED SEVERAL COMMANDS TO DROP THE METAL PIPE AND STICK. P.O. JACKSON THEN GAVE THE OFFENDER A VERBAL WARNING THAT HE WOULD BE TASED IF HE DIDN'T DROP BOTH THE WEAPONS. WALTER GUNN(OFFENDER) THEN LUNGED AT P.O GIBSON, P.O PAYNE, P.O JAUDON, P.O JONES AND P.O JACKSON AND IN FEAR OF RECEIVING A BATTERY P.O. JACKSON #3228 YELLED ?TASER, TASER , TASER? AND AT THIS TIME DEPLOYED HIS DEPARTMENT ISSUED TASER IN AN ATTEMPT TO SUBDUE THE ASSAILANT AND ELIMINATE THE THREAT POSED TO HIM AND HIS FELLOW OFFICERS. P.O JACKSON'S TASER STRUCK WALTER GUNN (OFFENDER), WHO THEN YELLED "I'M THE GOD OF DEATH" AND CONTINUED TO ADVANCE ON THE OFFCIERS WITH BOTH WEAPONS STILL IN HAND. REALIZING THE TASER DEPLOYMENT WAS UNSUCCESSFUL P.O JACKSON GAVE WALTER GUNN (OFFENDER) VERBAL COMMANDS TO STOP ADVANCING. AT THIS TIME P.O. JACKSON #3228 DEPLOYED HIS TASER AGAIN. WALTER GUNN (OFFENDER) THEN RAN INTO THE APARTMENT AND CLOSED THE DOOR. WHILE INSIDE THE APARTMENT WALTER GUNN (OFFENDER) SAID "I'M GOING TO KILL ALL YOU" REPEATING THAT STATEMENT SEVERAL TIMES. FEARING FOR THE SAFETY OF THE OCCUPANTS OF THE APARTMENT AND THE OBVIOUS DISTRESS OF THE OFFENDER AND BELIEF WHO MIGHT HURT HIMSELF OR OTHERS R/O JAUDON KICKED THE BACK DOOR OPEN TO GAIN AN ENTRY. WHEN R/O'S GAINED ENTRY INSIDE THE APARTMENT WALTER GUNN (OFFENDER) STARTED SWINGING THE METAL POLE AND WOODEN STICK AT P.O JAUDON AND P.O PAYNE WHILE INSIDE THE HALLWAY. WALTER GUNN (OFFENDER) WAS GIVEN VERBAL COMMANDS BY SGT. CIANNELLA #1068 BEAT 369, WHO ARRIVED ON SCENE TO ASSIST. WALTER GUNN (OFFENDER) RAN INTO THE LIVING ROOM AND ATTEMPTED TO KICK OUT THE WINDOW IN WHAT R/O'S BELIEVED WAS AN ATTEMPT TO ESCAPE. WALTER GUNN (OFFENDER) THEN TURNED AROUND AND LUNGED AT P.O JAUDON, P.O GIBSON, P.O PAYNE, P.O JACKSON AND SGT CIANNELLA #1069 WITH BOTH WEAPONS STILL IN HAND. P.O JACKSON DEPLOYED HIS MASE STRIKING WALTER GUNN (OFFENDER) IN THE FACE. WALTER GUNN (OFFENDER) CONTINUED



NARRATIVES

TO WILDLY SWING HIS WEAPONS AT R/O'S. OFFENDER THEN SUDDENLY DROPPED BOTH HIS WEAPONS AT WHICH TIME P.O JAUDON AND P.O PAYNE GRABBED WALTER GUNN (OFFENDER) BY BOTH ARMS IN AN ATTEMPT TO PERFORM AN EMERGENCY TAKE DOWN. R/O'S ATTEMPTED TO PLACE WALTER GUNN (OFFENDER) IN HANDCUFFS. BUT WALTER GUNN (OFFENDER) CONTINUED TO BE COMBATIVE BY SWINGING HIS ARMS AND KICKING HIS LEGS. WALTER GUNN (OFFENDER) WAS ACTIVELY RESISTING ARREST AND WAS NOT FOLLOWING VERBAL COMMANDS TO STOP FIGHTING AND STOP RESISTING. R/O'S WERE ABLE TO CONDUCT AN EMERGENCY FRONT CUFFING ON WALTER GUNN (OFFENDER). WALTER GUNN (OFFENDER) CONTINUED TO STRUGGLE AND ATTEMPT TO REMOVE HIS WRISTS OUT OF THE HANDCUFFS. AS A RESULT WALTER GUNN (OFFENDER) SUSTAINED CUTS TO HIS WRIST. WALTER GUNN (OFFENDER) CONTINUED TO BE COMBATIVE TOWARDS R/O'S AND CONTINUED KICKING HIS LEGS AND GRABBING AND REFUSING TO FOLLOW VERBAL DIRECTION. WALTER GUNN (OFFENDER) GRABBED P.O DELEON'S #16360 RIGHT LEG AND BIT P.O. DELEON IN THE ANKLE. R/O'S REQUESTED SHACKLES TO BE BROUGHT TO THE LOCATION AND EVENTUALLY PLACED THEM ON WALTER GUNN (OFFENDER) ANKLES FOR HIS SAFETY AS WELL AS THAT OF R/O'S. THE OWNER OF THE APARTMENT [REDACTED] (VICTIM) ARRIVED ON SCENE AN STATED THAT WALTER GUNN (OFFENDER) DOES NOT LIVE AT THIS LOCATION AND HAS A HISTORY OF MENTAL ILLNESS. 371 TRANSPORTED WALTER GUNN (OFFENDER) TO JACKSON PARK HOSPITAL FOR AN EVALUATION WHERE HE WAS INVOLUNTARILY ADMITTED AND TREATED BY DOCTOR FREDERICK. INVENTORY # 13661703 (1 WOODEN STICK AND METAL POLE). INVENTORY #13661714 (2 TASER CARTRIDGES AND PROBES). BEAT 5871 E.T. AKINS #14249 AND SELTZER #12643 ARRIVED ON SCENE AND TOOK PHOTOS OF THE RESIDENCE AND THEN RELOCATED TO JACKSON PARK HOSPITAL TO TAKE PHOTOS OF WALTER GUNN (OFFENDER).
