P/O DELCOIRO#11738 CURBED A VEHICLE FOR WRONG WAY ON A ONE WAY. [REDACTED] WAS CITED FOR NO VALID AND NO INSURANCE AND CHILD RESTRAINT REQ. P/O DELCORIO#11738 ISSUED AN I-BOND FOR [REDACTED] AND WAS REQUESTING AN ASSIST FOR A TWO MAN VEHICLE FOR A TOW OF THE CURBED VEHICLE IN WHICH DRIVER HAD NO INSURANCE AND NO D.L. DURING P/O DELCOIRO#11738 TRAFFIC STOP, OFFENDER APPROACHED P/O DELCOIRO#11738 AT WHICH TIME P/O DELCOIRO ORDERED OFFENDER TO STEP AWAY FROM THE SCENE. OFFENDER STATED "FUCK YOU SHE NEEDS MY PHONE" THEN THREW HIS PHONE IN THE DIRECTION OF P/O DELCOIRO#11738 WHICH FELL TO THE GROUND, UNDERNEATH CURBED VEHICLE. OFFENDER BEGAN YELLING TO P/O DELCOIRO TO PICK UP THE PHONE OFF THE GROUND. P/O DELCOIRO THEN AGAIN REQUESTED AN ASSIST VIA THE RADIO AND ORDERED OFFENDER TO STEP BACK. OFFENDER RETRIEVED HIS PHONE FROM UNDERNEATH CURBED VEHICLE AND CONTINUED TO ATTEMPT TO GIVE [REDACTED] HIS PHONE. P/O DELCORIO AGAIN REQUESTED OFFENDER LEAVE THE SCENE AND STEP AWAY FROM CURBED VEHICLE. P/O DELCOIRO#11738 (VICTIM) ORDERED OFFENDER TO LEAVE THE SCENE BECAUSE HE WAS STILL CONDUCTING AN INVESTIGATION. P/O DELCOIRO#11738 (VICTIM) APPROACHED OFFENDER TO AGAIN ORDER HIM TO STEP BACK FROM THE SCENE OFFENDER THEN REFUSED A LAWFUL ORDER.
