Event #05351, Cross Reference HZ-257474

This is an arrest by 008th District. A/O's responded to a bank hold up alarm call at Byline Bank, in which a subject had just robbed the bank. PO Keating #2918 Bt 6231 while working in the area observed the listed arrestee running in the area and being chased by civilians on foot. Po Keating #2918 confronted the listed arrestee at 50th and Karlov, and announces his office to the offender. At which time the listed arrestee pointed a handgun at PO Keating, While stating, "Shoot me now bitch" as he continued to run on foot. Po Keating gave out a flash message of the offender and a perimeter was established and officers began a systematic search of the area. During the search of yards, PO Clark #18361 observed a subject (arrestee) in the rear yard of 4949 S Karlov. The subject pointed a blue steel handgun at PO Clark #18361 while stating, "do something". PO Clark #18361 while in fear of his life shot several rounds from his service weapon at the offender and striking the offender, who later succumbed to the injuries at Mt Siani Hospital. No GIPP, No TRAP, No Invest Alert. No Serviceable Warrant.
