(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT#00497 IN SUMMARY, AOS OBSERVED THE LISTED OFFENDER DRIVING THE LISTED VEHICLE IN REVERSE UNSAFELY BACKING UP IN THE PARK LANE ON THE WESTSIDE OF KOSTNER FAILING TO WEAR HIS SEAT BELT. AO STOPPED TO INVESTIGATE PULLING NEXT TO THE OFFENDER AS HE WAS REVERSING. AOS ASKED THE OFFENDER IF HE HAD A DL, AT WHICH TIME HE QUICKLY EXIT THE VEHICLE PUTTING HIS HANDS IN HIS POCKETS AND STATING, NO IT IS REVOKED. AT THIS TIME AOS ORDERED HIM TO TAKE HIS HANDS OUT OF HIS POCKETS AS THEY EXITED THEIR VEHICLE ATTEMPTING TO TAKE THE OFFENDER INTO CUSTODY FOR FAILING TO PRODUCE A DL. AT THIS TIME THE OFFENDER REFUSED TO TAKE HIS HANDS OUT OF HIS POCKETS EVEN AFTER AOS TOLD HIM SEVERAL TIME TO DO SO. AOS ATTEMPTED TO TAKE THE OFFENDER INTO CUSTODY GRABBING HIS ARMS WHEN THE OFFENDER PULLED AWAY SWINGING HIS ARMS THEN STRIKING AO ZAYAS#10661 IN THE HEAD WITH HIS LEFT ELBOW THEN GRABBING HIS RIGHT HAND AS HE PERFORMED AN ESCORT HOLD AND BENDING HIS RIGHT RING FINGER BACK CAUSING AO EXTREME PAIN WHERE HE YELLED OUT IN PAIN. AO OSORIA #14025 CONTINUED TO GIVE THE OFFENDER VERBAL COMMANDS BUT THE OFFENDER CONTINUED TO SWING HIS ARMS IN AN ATTEMPTED TO DEFEAT THE ARREST TURNING HIS BODY TOWARDS AOS TAKING A FIGHTING STANCE STRIKING AO OSORIA #14025 IN THE CHEST WITH HIS ELBOWS AND A CLOSED FIST, CAUSING AO TO YELL OUT IN PAIN. THE OFFENDER THEN FLED ACROSS THE STREET EAST BOUND WHERE AO ZAYAS #10661 DEPLOYED HIS TASER ATTEMPTING TO AFFECT THE ARREST, STRIKING THE OFFENDER CAUSING HIM TO FALL TO THE GROUND STRIKING HIS FACE AGAINST A PARKED VEHICLE WHICH CAUSED A LACERATION ABOVE HIS LEFT EYE. AOS ATTEMPTED TO TAKE THE OFFENDER INTO CUSTODY AGAIN WHEN THE OFFENDER STOOD UP PULLING OUT A PURPLE IN COLOR BAG ABOUT THE SIZE OF A GOLF BALL FROM HIS WAIST BAN AREA THROWING IT ON THE SIDEWALK IN FRONT OF THE PARKED VEHICLE AND THEN ATTEMPTING TO FLEE AGAIN. AO OSORIA #14025 WAS ABLE TO OBSERVE THE OBJECT AND WHERE IT LANDED WHILE PLACING 1 HANDCUFF ON THE OFFENDERS RIGHT WRIST BUT THE OFFENDER CONTINUED TO BATTER AO PUNCHING HIM IN THE HEAD AND UPPER CHEST THEN STIFFING HIS BODY. AO ZAYAS #10661 ACTIVATED HIS TASER 3 MORE TIMES BUT IT DID NOT AFFECT THE OFFENDER AS HE KEPT FIGHTING STRIKING AO ZAYAS #10661 IN THE LEFT HAND WITH A CLOSED FIST. AO ZAYAS #10661 THEN STUCK THE OFFENDER IN THE FACE WITH AN OPEN HAND STRIKE ALONG WITH A CLOSED FIST AND A KNEE STRIKE ALONG WITH AN ELBOW STRIKE BUT THE OFFENDER CONTINUED TO FIGHT WITH AOS. AOS WHERE ABLE TO PERFORM A EMERGENCY TAKE DOWN APPLYING PRESSURE TO SENSITIVE AREAS AND PLACING THE OFFENDER INTO CUSTODY WITH FURTHER INCIDENT. AO ZAYAS #10661 RECOVERED THE OBJECT THE OFFENDER TOSSED FROM THE SIDEWALK DISCOVERING IT TO BE A PURPLE CROWN ROYAL BAG (INV#13591175) CONTAINING 31 CLEAR ZIP LOCK BAGGIES EACH CONTAINING A CRUSHED GREEN LEAF LIKE SUBSTANCE SUSPECT CANNABIS, 1 CLEAR ZIP LOCK BAG CONTAINING A WHITE ROCK LIKE SUBSTANCE, SUSPECT CRACK COCAINE AND 3 CLEAR ZIP LOCK BAGGIE EACH CONTAINING A WHITE POWDER LIKE SUBSTANCE SUSPECT HEROIN(INV#13591140). AMBULANCE 23 ARRIVED ON SCENE TRANSPORTING THE OFFENDER TO SAINT ANTHONY HOSPITAL WHERE HE WAS TREATED AND RELEASED BY DR PITZELE.
