[REDACTED] [REDACTED] (VICTIM) STATED SHE WAS INSIDE A STALL WHEN SHE HEARD A CHILD YELLING "I WANT MY MOMMY" AFTER WHICH SHE RAN OUT OF RESTROOM AND DID NOT SEE [REDACTED] [REDACTED] (VICTIM). [REDACTED] [REDACTED] (VICTIM) RETURNED TO RESTROOM AND OBSERVED REESE HARTSTIRN(OFFENDER) WITH HIS HANDS STILL AROUND [REDACTED] [REDACTED] (VICTIM) NECK. [REDACTED] [REDACTED] (VICTIM) STATED SHE PUSHED REESE HARTSTIRN(OFFENDER) AND TOOK [REDACTED] [REDACTED] (VICTIM) AND EXITED THE RESTROOM.
