INVESTIGATION:

The Reporting Detectives were assigned by Sgt. RONEY #2244 of this command, to investigate the aggravated assault to a police officer which occurred at 4949 S. Karlov Ave. The Reporting Detectives relocated, immediately, to that address and observed the area cordoned off with crime scene tape and protected by 008th District personnel.

The Reporting Detectives discovered that Byline Bank, located at 4970 S. Archer Ave., had been robbed at gunpoint. The offender, now known as (N.K.A.) Michael JOHNSON, fled on foot pursued by employees of the bank. As JOHNSON fled he ran westbound across Pulaski Ave at 49th St. where he was observed by P.O. KEATING. P.O. KEATING gave a flash message and pursued JOHNSON in his vehicle. JOHNSON then pointed a blue steel semi-automatic handgun at KEATING and continued to flee on foot eventually escaping in a gangway at 4955 S. Karlov Ave.

The Reporting Detectives learned that 009th District tactical officers John CLARK and Patrick THIRY, working Bt. 862A, responded to a holdup alarm at Byline Bank and then to the pursuit of JOHNSON by P.O. KEATING. P.O. CLARK then met up with P.O. KEATING and began a search of the immediate area. P.O. CLARK found JOHNSON lying on his back in the yard at 4949 S. Karlov Ave. JOHNSON was holding a blue steel semi-automatic pistol in his right hand and pointed it at P.O. CLARK. P.O. CLARK ordered JOHNSON to drop the gun and JOHNSON refused stating, "Do something." P.O. CLARK discharged his service weapon.

The death of JOHNSON is a separate investigation (HZ-257760) conducted solely by the Independent Police Review Authority (IPRA) and independent of the armed robbery HZ-275271) and aggravated assault to a police officer investigations conducted by the Chicago Police Department.

Responding officers secured an unknown make and model .380 caliber blue steel semi-automatic handgun, serial #G27851, loaded with seven live rounds in the yard next to JOHNSON which was later recovered and inventoried by Bt. 5812 E.T. G. MANGUERRA #14098.

The victims; P.O. KEATING and P.O. CLARK, and the witnesses; P.O. THIRY and P.O. FUELLING relocated to Area Central Detective Division in order to assist in the investigation of the aggravated assault to a police officer.

P.O. KEATING, on duty and working Bt. 6231 assigned to Unit 189, related the following in essence, not verbatim regarding the aggravated assault to a police officer.

P.O. KEATING was driving a [REDACTED] southbound on Pulaski Ave. near 49th St. and observed a masked subject, N.K.A. Michael JOHNSON, run across Pulaski Ave. in a southwest direction, chased by two male subjects wearing shirts and ties. JOHNSON continued to run southbound on Pulaski Ave. before turning westbound. P.O. KEATING drove to 50th St. and then turned westbound where he observed JOHNSON running westbound across the west alley of Pulaski Ave. P.O. KEATING continued, in his vehicle, westbound on 50th St. and observed JOHNSON run westbound across Komensky Ave. P.O. KEATING turned his vehicle, northbound, into the west alley of Komensky Ave. where JOHNSON ran southbound, past P.O. KEATING'S vehicle and then westbound on 50th St. P.O. KEATING reversed his vehicle onto 50th St. and then drove westbound and observed JOHNSON near the north curb of 50th St. west of the alley. P.O. KEATING, his vehicle facing JOHNSON, announced his office at which time JOHNSON walked towards the middle of 50th St. and dropped a backpack that he had been carrying, to the ground. JOHNSON had his right hand in his jacket pocket and when he removed it he was holding a blue steel semi-automatic handgun. JOHNSON then pointed the handgun at P.O. KEATING and stated, "Shoot me now bitch." JOHNSON then retrieved the backpack and ran westbound on 50th St and then northbound on Karlov Ave. P.O. KEATING pursued, in his vehicle, and observed JOHNSON run onto front porch of the residence located at 4955 S. Karlov Ave. JOHNSON then jumped off the porch and ran eastbound in the gangway before jumping the backyard fence into the backyard of the house to the north. P.O. KEATING related that when JOHNSON jumped off the porch he noticed that JOHNSON had changed clothes. P.O. KEATING now drove his vehicle northbound on Karlov Ave. and then eastbound on 49th St. When P.O. KEATING approached the east alley of Karlov Ave. he observed an unmarked police vehicle northbound in the alley. P.O. KEATING drove his vehicle around the block, traveling eastbound on 49th St., southbound on Komensky Ave. and then westbound on 50th St. before turning northbound into the west alley of Komensky Ave. again. P.O. KEATING observed that the unmarked police vehicle he saw had parked four to five houses north of 50th St. and he saw P.O. CLARK, on foot, in the alley. P.O. KEATING parked his vehicle south of the unmarked vehicle and met with P.O. CLARK on foot. P.O. KEATING and P.O. CLARK began a search of the immediate area. P.O. KEATING walked around to Karlov Ave. while P.O. CLARK remained in the alley. As P.O. KEATING walked northbound on Karlov Ave. he heard multiple gunshots. P.O. KEATING ran to the gangway between 4947 and 4949 S. Karlov Ave. where he saw JOHNSON in the backyard of 4949 S. Karlov Ave. P.O. KEATING observed P.O. CLARK in the backyard of 4747 S. Karlov Ave. and heard him state, "He's still got the gun." P.O. KEATING approached JOHNSON and observed that he was lying on his back with a handgun next to him. P.O. CLARK told P.O. KEATING that JOHNSON had been hit. P.O. KEATING then called for an ambulance on his police radio.

P.O. CLARK, on duty and working Bt. 862A assigned to the 008th District, related the following in essence, not verbatim.

NARRATIVES

P.O. CLARK related that he was working with, P.O. THIRY, assigned to the Post Shooting Mission, the area bounded by 47th St. on the north to 55th St. on the south and by Pulaski Ave. on the east to Cicero Ave. on the west. P.O. CLARK related that he was driving an unmarked vehicle, eastbound on Archer Ave., when he monitored a call of a holdup alarm at Byline Bank. P.O. CLARK then monitored an additional radio transmission from Bt. 6231 (P.O. KEATING) that an offender had pointed a gun at him at 50th and Karlov Ave. P.O. CLARK drove his vehicle northbound on Karlov Ave. from Archer Ave. to 50th St. and observed civilians pointing northbound in the alley between Karlov Ave. and Komensky Ave. P.O. CLARK drove into the alley where he parked the unmarked vehicle and exited on foot. P.O. CLARK met P.O. KEATING who provided him with a clothing description of JOHNSON. P.O. CLARK began searching the backyards of the residences traveling northbound towards 49th St. before turning back southbound to continue his search. When P.O. CLARK supported himself on the wooden fence of 4747 S. Karlov Ave. he observed JOHNSON in the backyard of 4949 S. Karlov Ave. JOHNSON was lying, face up, on the ground and pointed a handgun at P.O. CLARK. P.O. CLARK announced his office and ordered JOHNSON to drop the gun. JOHNSON continued to point the handgun at P.O. CLARK and responded by stating, "Do something." P.O. CLARK discharged his service weapon.

As a result of the aggravated assault with a handgun committed by JOHNSON, P.O. CLARK discharged his service weapon causing the death of JOHNSON. That investigation is being conducted solely by the Independent Police Review Authority (IPRA) and independent of any investigations conducted by the Chicago Police Department.

P.O. THIRY, on duty and working Bt. 862A assigned to the 008th District, related the following in essence, not verbatim.

P.O. THIRY related that he was working with his partner P.O. CLARK when he monitored a call of a holdup alarm at Byline Bank located at Archer Ave. and Pulaski Ave. P.O. THIRY related that P.O. CLARK was driving an unmarked vehicle towards the bank when an updated radio transmission informed him that a police officer had a gun pointed at him at 50th and Kolin Ave. P.O. CLARK drove the vehicle northbound on Karlov Ave. from Archer Ave. As P.O. CLARK approached 50th St. P.O. THIRY observed two male Hispanics dressed in shirts and ties motioning towards the east alley of Karlov Ave. P.O. CLARK drove northbound into the east alley of Karlov Ave. where he received a description of the offender from the two male Hispanics and broadcast it over his police radio. P.O. THIRY and P.O. CLARK exited their vehicle on foot. P.O. THIRY walked northbound in the east alley of Karlov Ave. and then eastbound to the west alley of Pulaski Ave. P.O. THIRY searched the surrounding area and returned to the east alley of Karlov Ave. where he began walking southbound searching backyards. P.O. THIRY related that he was approximately three yards north of where the aggravated assault of P.O. CLARK occurred when he heard P.O. CLARK yell, "Drop the gun" three times. P.O. THIRY ran southbound and heard multiple gunshots. P.O. THIRY then observed P.O. CLARK standing on fence in the backyard. P.O. THIRY entered the backyard and heard P.O. CLARK state, "He's still got the gun." P.O. THIRY then jumped the fence into the yard to the south and saw JOHNSON lying on his back holding a handgun near his chest. P.O. THIRY then observed P.O. FUELLING enter the backyard and kick the gun out of JOHNSON'S hand. P.O. THIRY then asked the dispatcher to get an ambulance.

P.O. FUELLING, on duty and working Bt. 806G assigned to the 008th District, related the following in essence, not verbatim.

P.O. FUELLING related that he was working with P.O. T. MCKEON #7210 when he monitored a call of a holdup alarm at Byline Bank. P.O. FUELLING also heard an outside unit give out a radio call of a man with a gun. P.O. MCKEON drove to 49th and Karlov Ave. where P.O. FUELLING exited the vehicle on foot. P.O. FUELLING heard Bt. 810 setting up a perimeter of the surrounding yards. P.O. FUELLING related that he was in the alley of the 4900 block of south Karlov Ave. when he heard multiple gunshots. P.O. FUELLING related that he gave out a call of loud reports and ran southbound in the alley. P.O. FUELLING then heard a male voice yelling "Put down the gun." P.O. FUELLING related that he turned, westbound, into the gangway of 4947 S. Karlov Ave. and saw P.O. CLARK straddling the backyard fence pointing his gun into the yard of 4949 S. Karlov Ave. P.O. FUELLING heard P.O. CLARK state, "Someone's got to get him. I've got him covered." P.O. FUELLING related that he jumped the fence into the backyard of 4949 S. Karlov Ave. P.O. FUELLING related that he saw two large air conditioners in the back yard. When he walked around the air conditioners he saw JOHNSON lying face up with his back and shoulder area lying on a backpack and his knees slightly bent. JOHNSON was holding a black semi-automatic handgun in his right hand which he held close to his chest. P.O. FUELLING gave JOHNSON an order to drop the gun but he did not comply. P.O. FUELLING related that he used his left foot to kick the gun from JOHNSON'S hand onto the ground. P.O. FUELLING related that he then stepped on the handgun so JOHNSON could not re-arm himself. P.O. FUELLING felt for a pulse and heard a radio call requesting an ambulance. P.O. FUELLING related that a CFD ambulance arrived and took JOHNSON away on a stretcher.

██████████ was interviewed at Honda City Dealership, located at 4950 S. Pulaski Ave., where he works ██████████ related the following in essence not verbatim.

██████████ related that, on 9 May 6, he was riding southbound in the west alley of Pulaski Ave. in a vehicle driven by ██████████ an employee of Honda City. ██████████ observed a male subject, N.K.A. Michael JOHNSON, being chased, southbound, in the alley on foot by two other male subjects dressed in business attire. As they approached 50th St. the two subjects dressed in business attire flagged down the driver of a gray Nissan Altima. JOHNSON turned westbound on 50th St. and the driver of the Nissan Altima followed him. ██████████ drove westbound on 50th St. and stopped at a stop sign on Komensky Ave. ██████████ observed JOHNSON and the Nissan Altima one half block west on 50th St. RUIZ then observed JOHNSON drop a backpack to the ground and point a handgun at the Nissan Altima. ██████████ turned southbound on Komensky Ave. and ██████████ called 911. ██████████ then observed JOHNSON pick up the backpack and run into the alley.

The investigation also revealed that another employee of Honda City, ██████████ witnessed the incident and called 911.
