NARRATIVES



Investigation:

On 25 May 2016, at approximately 1350 hours, Sgt. VASQUEZ #2664 of this command assigned Detective Paul PERAINO #21404 an aggravated assault with a handgun to the police. Reporting Detective (R/D) was advised that an off-duty Chicago Police Officer observed an unknown offender shooting at citizens in a parking lot. The off-duty officer then discharged his weapon after the unknown offender pointed his weapon at the officer. R/D proceeded to 6712 S. Stony Island Ave.

Upon arrival, R/D observed the location to be the parking lot of a strip mall. The west side of the parking lot was bordered by Walgreens drug store. 67th street bordered the north side of the parking lot and Stony Island bordered the east end. The south end of the parking lot was the north alley of 67th place or the south alley of 67th street. A currency exchange and several other commercial businesses bordered the southeast corner of the parking lot.

R/D observed yellow crime scene tape blocking the entrances to the parking lot. Uniformed Chicago Police Officers were guarding the crime scene. R/D observed a total of six (6) spent 9mm shell casings in the east section of the parking lot and one (1) bullet fragment toward the center of the parking lot. Also observed was (1) spent 9mm shell casing on the sidewalk, next to the front doors of Walgreens, on 67th street. R/D also observed five (5) spent .38 caliber shell casings, adjacent to the off-duty officer's personal vehicle. The vehicle was parked next to the Walgreens loading dock, on the west end of the parking lot.

R/D met with Detective STANIK #20953 who related that he conducted an interview with the off-duty officer, P.O. Conway GARLINGTON #4553. P.O. Conway GARLINGTON provided the following version of events, in essence, not verbatim.

P.O. Conway GARLINGTON related that he had just dropped off his niece at the Walgreens to make a purchase. P.O. Conway GARLINGTON then parked his vehicle, facing east, next to the Walgreens loading dock. P.O. Conway GARLINGTON then observed three male blacks walking from east to west, though the parking lot. A red automobile entered the parking lot from 67th street and passed by P.O. Conway GARLINGTON'S vehicle and stopped facing east. The three unknown males and engaged in conversation with the two female occupants. The passenger exited the vehicle and the driver then pulled into a parking spot. The three males and one female continued to engage in conversation for approximately five minutes.

P.O. Conway GARLINGTON heard gunfire and observed UNKNOWN male black offender wearing a hooded sweatshirt and a skeleton Halloween mask firing a handgun towards the males. Two of the males fled toward Walgreens. The offender continued to chase and shoot at the males.

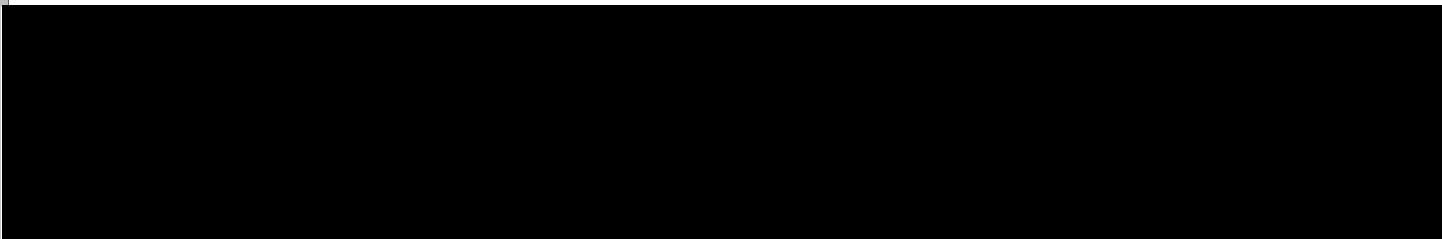
P.O. Conway GARLINGTON related that he exited his vehicle and yelled, "Police stop, Police stop" as he drew his weapon. The offender then looked in P.O. Conway GARLINGTON'S direction and then pointed a handgun at P.O. Conway GARLINGTON. P.O. Conway GARLINGTON, fearing for his safety and that of the males discharged his weapon, firing five times, at the offender. The offender continued to run, firing one additional shot at the two males. The offender then ran west on 67th street.

P.O. Conway GARLINGTON reloaded his weapon and pursued the offender. The offender made good on his escape. At this time, the two males emerged from the Walgreens. One of the males stated that he had been shot. P.O. Conway GARLINGTON advised the male to remain on-scene and seek medical attention and the police. Both males left the scene.

P.O. Conway GARLINGTON provided a flash message to a police unit that heard the gunfire. P.O. Conway GARLINGTON also dialed 911. A short time later, P.O. Conway GARLINGTON observed that one of the males that were shot at returned to the parking lot. P.O. GARLINGTON had nothing further to state at this time.

R/D met with Detective DEENIHAN #20739 who related that he had a conversation with [REDACTED] [REDACTED] one of the males

that were shot at by the unknown offender. The following was a summary, in essence, not verbatim.



NARRATIVES

Detective DECICCO #21006 and Sgt. VASQUEZ #2664 canvassed the area and located a skeleton mask in a dumpster, behind the Walgreens. This was also in the same alley that the offender fled through. Sgt. VASQUEZ also located a 9mm Luger handgun wrapped in a hooded sweatshirt, under the back porch, located at 1522 e 67th place.

During the canvas, witnesses were located who observed the offender discard the recovered firearm and sweatshirt under the porch, while in the company of another individual. The Crime Lab was summoned to the scene. The crime scenes were photographed, video recorded and all probative evidence, was documented and collected.

R/D reviewed and recovered external surveillance video from the Currency Exchange, where the offender emerged and the Walgreens.

A check of CABOODLE revealed no POD cameras in the immediate area.

This case is on-going.
