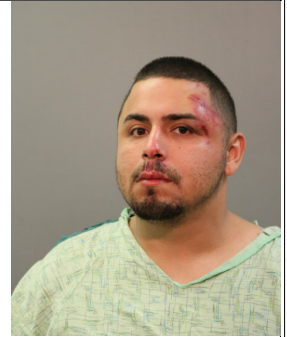

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

#07342 Above arrested after subject was observed by Bt. 2535, P.O Feliciano #12949, driving listed vehicle the wrong way on a one way street. Bt. 2535 attempted to conduct a traffic stop on said vehicle at which time above subject refused to stop. After a brief pursuit Bt 2530 terminated the chase. While A/O's were touring the area, above suspect while S/B on Ridgeway nearly collided with Bt. 2561B at Potomac. Bt 2561B notified OEMC and followed offender to 1100 N Lawndale where above suspect exited the vehicle and fled on foot. A/O's gave chase giving verbal commands for suspect to stop. Above continued running with his right hand in the front of his body refusing all verbal commands. A/O Ramkumar, fearing for his safety and the safety of others, deployed his taser which immediately ceased all resisting actions by offender and was taken into custody and read rights. A/O's requested CFD who responded and transported subject to Norweigan Hospital and treated and released for injuries sustained when he fell forward after being tased. Inventory search of vehicle revealed 2 packets of "synthetic marijuana" and 3 burnt hand rolled cigars also containing "synthetic marijuana". Name check revealed above to have a suspended D/L. SSL 213
