INCIDENT NARRATIVE	<p>(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)</p> <p>EVENT#EVENT#09610, in summary; r/o were conducting routine patrol around above stated area and observed ROBERT FOREMAN(OFFENDER) in front of 8810 s Wabash, an abandon property drinking alcohol (remy martin) on the public way. r/o RIVAS#8341 (VICTIM AND COMPLAINANT) exited patrol vehicle and went to issue an anov/arrest ROBERT FOREMAN(OFFENDER) who then began to flee. r/o gave chase and gave flash message of offenders description of a m/1 with dread locks, white muscle t-shirt who r/o now knows as ROBERT FOREMAN(OFFENDER) after a brief foot chase offender was caught at 8831 s Wabash in the front yard. a/o rivas #8341 placed offender right arm in handcuffs, at which time offender became an active resister by swinging both arms at officer rivas#8341 with the handcuffs still connected. RIVAS#8341 (VICTIM AND COMPLAINANT) again gave verbal commands for offender to give a/o hands and offender did not comply. offender continued swinging his arms and hands to defeat a/o arrest. A/o in immanent threat of receiving a battery, a/o conducted an emergency takedown. Once on the ground, offender still was actively resisting a/o rivas#8341 by moving both his arms back and forth still attempting to defeat the arrest. a/o rivas#8341 struck offender with one closed fist to the face and several elbow strikes to the face to effect the arrest. a/o bilina#6269 arrived on scene and offender would still not comply by not giving a/os his arms. a/o bilina#6269 helped place offender in custody. once offender was placed in custody all force stop. Offender denied medical attention on scene. Trrs completed. while offender was running from a/o offender lost his shoe. the shoe and other property that offender claimed he had on him was never recovered.
