(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT # 10897 IN SUMMARY, ON THE ABOVE DATE AND TIME A/O'S RESPONDED TO A CALL OF A PERSON WITH A GUN THAT WAS REPORTED BY OFF DUTY SGT. PENDARVIS #1937 AT APPROXIMATELY 50TH AND WABASH AVE. THE FLASH MESSAGE GIVEN BY OEMC WAS A MAROON CHEVORLET EQUINOX, WITH A MISSING BUMPER, OCCUPIED 2X, 1 OCCUPANT POSSIBLY WITH DREADLOCKS. A/O'S AND BEAT 231 BEGAN TO TOUR THE AREA, AT WHICH TIME A/O'S OBSERVED ABOVE MENTIONED VEHICLE AT APPROXIMATELY 4300 S WABASH AVE, AT WHICH TIME THE SUSPECT'S VEHICLE THEN FLED. AFTER A BRIEF PURSUIT, SUSPECT'S VEHICLE THEN CRASHED AT ADDRESS OF ARREST (20 E 42ND ST). THIS CRASH WAS DOCUMENTED UNDER HZ 317472, AND IS CURRENTLY BEING INVESTIGATED BY MAIU. UPON A/O'S ARRIVAL TO THE SCENE, A/O OBSERVED GIPSON, DOMINIC (OFFENDER) HANGING OUT OF THE DRIVER'S SIDE DOOR OF THE CRASHED VEHICLE, WHICH WAS LATER IDENTIFIED TO BE STOLEN UNDER RD# HZ315230. VEHICLE WAS TAKEN INTO CUSTODY BY MAIU. GIPSON, DOMINIC (OFFENDER) WAS THEN TAKEN BY CFD AMBULANCE #57 TO STROGER (COOK COUNTY) HOSPITAL, WHERE HE IS STILL BEING TREATED BY ATTENDING PHYSICIAN DR. KAMINSKY. CURRENTLY IS LISTED IN STABLE CONDITION. E.T. NORRIS #19686 ON SCENE AT STROGER HOSPITAL TO FINGER PRINT OFFENDER AT 2105 HRS. OFFENDER HAS NO ACTIVE INVESTIGATIVE ALERTS. OFFENDER IS A DOCUMENTED MAFIA INSANE VICE LORD (43RD AND MICHIGAN), AND SSL SCORE OF 388. HE HAS NO MONEY TO A/O'S KNOWLEDGE ON HIS PERSON AT THIS TIME. AT THE TIME OF THIS REPORT OFFENDER IS CURRENTLY ADMITTED AT STROGER HOSPITAL AND MAY REQUIRE FURTHER MEDICAL CARE. DETECTIVE VALDEZ #529, BT 5105, NOTIFIED.
