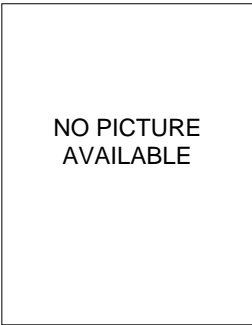

IN SUMMARY: ABOVE ARRESTEE [REDACTED] ED INTO CUSTODY AFTER HE WAS IDENTIFIED AS THE SUBJECT THAT STRANGLED VICTIM#1 [REDACTED] WITH HIS HANDS AROUND HER NECK CAUSING HER TO BECOME UNCONSCIOUS. SUBJECT HARTSTIRN HAD PICKED UP THE 8 YEAR OLD VICTIM AND CARRIED HER INTO A BATHROOM STALL WHERE HE THEN CLOSED THE DOOR STOPPING THE VICTIM FOR LEAVING AND TELLING HER THAT HER MOTHER WAS NOT COMING FOR HER. ARRESTEE ALSO PUSHED VICTIM #2 [REDACTED] WHEN SHE CAME INTO THE STALL TO RESCUE HER UNCONSCIOUS DAUGHTER. CITIZENS INSIDE STORE HELD THE OFFENDER FOR THE POLICE AFTER THEY WERE ALERTED TO HIS CRIMES. R/O TRANSPORTED SUBJECT TO 001 FOR PROCESSING. ARRESTEE VOLUNTEERED THAT HE WAS INSIDE THE RESTROOM AND CHOKED THE VICTIM AND THAT HE HAD FUCKED UP. DURING PROCESSING INSIDE 001 ARRESTEE BECAME AGGRESSIVE TOWARD R/O SWINGING HIS FIST IN R/O'S DIRECTION. RIGHTS GIVEN PER MIRANDA.
