(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT #17264 NO KNOWN INVESTIGATIVE ALERTS OR WARRANTS G.I.P.P T.R.A.P AT THIS TIME

ABOVE ARRESTED ON SIGNED COMPLAINTS IN THAT WHILE ENGAGED IN A VERBAL DISPUTE WITH VASQUEZ,(EX-BOYFRIEND), VASQUEZ BEGAN TO FORCIBLY PUSH VICTIM CAUSING HER TO FALL AND STRIKE THE LEFT SIDE OF HER HEAD ON THE GARAGE CONCRETE FLOOR CAUSING PAIN, AS SHE ATTEMPTED TO GET BACK UP FROM THE GROUND VASQUEZ HELD HER TO GROUND, SHOUTING "YOU AIN'T GOING NOWHERE!" ON SCENE OFFICERS HEARD THIS VERBAGE WHILE ON THE OUTSIDE OF THE GARAGE WHILE ATTEMPTING TO GAIN ENTRY INTO THE LOCKED GARAGE. OFFICERS STILL HEARING THE YELLING KNOCKED AND ANNOUNCED THEIR OFFICE AND FORCED ENTRY INTO THE GARAGE OBSERVING VASQUEZ ON TOP OF THE VICTIM. OFFICERS ATTEMPTED TO PLACE VASQUEZ INTO CUSTODY WHEN HE BECAME AN ASSAILANT BY SWINGING CLOSED FISTS AT P.O K. FRY, CAUSING P.O FRY TO DEPLOY HIS ASP BATON TO GAIN CONTROL OF THIS ASSAILANT. AN EMERGENCY TAKEDOWN WAS CONDUCTED AND VASQUEZ ACTING AS AN ACTIVE RESISTER WAS PULLING AWAY, AND SWINGING HIS ARMS IN AN ATTEMPT TO DEFEAT ARREST. P.O LOBIANCO DELIVERED OPEN HAND STRIKES AND P.O FRY USED ARM BAR AND WRIST LOCK TECHNIQUES AND WAS ABLE TO PLACE VASQUEZ UNDER ARREST. DURING THIS STRUGGLE VASQUEZ SUFFERED AN INJURY TO RIGHT EYE, AND IS BEING TREATED WILL BE RELEASED FROM TRINITY HOSPITAL.
