INCIDENT NARRATIVE

IN SUMMARY, ABOVE WAS ARRESTED AFTER DURING A TRAFFIC STOP IN THE ALLEY OF 8310 S. KERFOOT, THE ABOVE SUBJECT REPEATEDLY REFUSED TO PROVIDE R/O'S WITH HER DRIVERS LICENSE. AS R/O ATTEMPTED TO TAKE THE ABOVE SUBJECT FROM INSIDE THE VEHICLE, THE OFFENDER STRUCK THE VICTIM IN THE FACE WITH A CLOSED FIST, THE ABOVE SUBJECT THEN GRABBED HOLD OF VICTIM'S VEST. THE OFFENDER THEN PLACED HER VEHICLE IN REVERSE WHILE STILL HOLDING ONTO VICTIM, DRAGGING HER ALONG WITH THE VEHICLE APPROXIMATELY 50 FEET. BT 622 PO LOPEZ PURSUED ON FOOT, WHILE CALLING FOR ASSIST UNITS. VICTIM (PO MORSI) RETURNED TO HER MARKED VEHICLE AND PURSUED THE OFFENDER, WHOSE VEHICLE WAS STILL IN REVERSE, ONTO THE STREET SIDE OF KERFOOT. BROWN THEN STRUCK A PARKED VEHICLE AND ATTEMPTED TO FLEE SCENE. MORSI PROCEEDED FORWARD, BLOCKING THE OFFENDER FROM FLEEING. BROWN WAS PLACED INTO CUSTODY. VICTIM PO MORSI WAS TRANSPORTED TO NORTHWESTERN HOSPITAL BY CFD #16. PO MORSI WAS TREATED AND RELEASED BY DR. ALDEEN.
