This is an on view arrest by 009th dist tact team bt 962e under event# 16681. Above in custody, after a/o's on directed patrol in the area of a recent homicide which occured in the 900 Blk. W. Garfield 28APR14 under Rd # Hx 240739, observed above offender and 2 other known "Bpsn" gang members standing in front of the residence located at 5246 S. Sangamon, a residence where a/o's have recovered several firearms. As a/o's slowed down and began to approach same individuals, above offender fled on foot. A foot pursuit ensued, during which time offender fled thru the rear yard and over the rear fence located at 5246 S. Sangamon. A/o Vahl continued chase and followed offender e/b in the south alley of the 900 blk w. 53rd st. observing offender toss an unk item over the rear fence located at 941 W. 53rd st. Offender subsequently attempted to climb the rear chain link fence located at 939 W. 53rd st., losing his footing as he ascended in the now steady falling rain. Offender subsequently fell backwards from atop said fence to the pavement in the alley. A/o Vahl attempted to place offender in custody as he lay on his back, at which time, offender began to flail his arms and kick his legs at A/o Vahl not allowing a/o to gain control of him and place him on his stomach as repeatedly ordered to by a/o vahl. A/o Vahl subsequently utilized several closed hand strikes to offender's head who was now an assailant. Offender was subsequently rolled onto his stomach and placed in custody without further incident as A/o Barsch arrived on scene to assist. A/o's relocated to the aforementioned rear vard located at 941 w. 53rd st and recovered 1 small clear ziplock bag containing suspect cannabis. Offender given rights, taken 009th dist. Post miranda at approx 2115hrs in the 009th processing area, offender related that he only had that one nickel bag of weed and ran because he was scared after having just locked up for possession of cannabis. Offender sustained lacerations to the top and side of his head and was transported to Mercy Hospital for treatment. Further investigation revealed offender as a result of this arrest is in violation of the conditions of bail bond in that arrestee had been previously arrested for possession of cannabis under cb# 18871193 on 09apr14 and was let to bail bond under bond # d8725448 br 34/2 --16may14.
