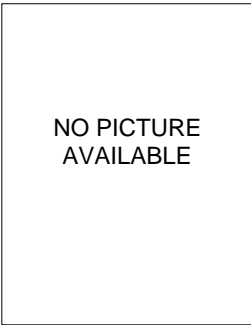

ARREST REPORTING

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT # 18169 IN SUMMARY, AOS OBSERVED OFFENDER NOW KNOWN AS ALAN SHIELDS WALKING INTO THE EAST ALLEY OF 6900 S ASHLAND AVE WITH ANOTHER INDIVIDUAL. AOS, SUSPECTING A NARCOTICS TRANSACTION IN PROGRESS, ALSO RELOCATED TO THE EAST ALLEY OF THE 6900 BLOCK OF S ASHLAND AVE. UPON VIEWING AOS IN THEIR MARKED VEHICLE BOTH OFFENDER'S BODY LANGUAGE IMMEDIATELY CHANGED IN THAT BOTH OFFENDERS ABRUPTLY STOPPED, SHIFTED THEIR WEIGHT, AND DARTED THEIR EYES AWAY FROM AO'S BEFORE BEGINNING TO WALK AGAIN. AOS APPROACHED OFFENDERS FOR A FIELD INTERVIEW. AOS ASKED OFFENDER IF HE HAD ANY WEAPONS OR CONTRABAND ON HIS PERSON. OFFENDER BECAME EXTREMELY AGGRESSIVE. AOS PERFORMED A PROTECTIVE PAT DOWN AND FELT A SHARP OBJECT IN THE FRONT POCKET. AOS WENT INTO SAID POCKET, RETRIEVED THE OBJECT AND OBSERVED IT TO BE A STEAK KNIFE WITH A STEEL HANDLE. AOS EXPLAINED TO ALAN SHIELDS(OFFENDER) THAT HIS POCKETS WOULD BE SEARCHED THOROUGHLY FOR ANY ADDITIONAL WEAPONS. AS AOS REACHED FOR OFFENDERS POCKET, OFFENDER KNOWINGLY AND INTENTIONALLY MADE PHYSICAL CONTACT WITH THE OFFICER IN THAT HE FORCEFULLY GRABBED AO COLEMAN BY THE WRIST AND SHOVED HIM AWAY IN AN AGGRESSIVE MANNER. AO COLEMAN PLACED OFFENDER IN A WRISTLOCK AND ATTEMPTED TO PLACE THE OFFENDER INTO CUSTODY. OFFENDER TIGHTENED HIS GRIP AND INTERLOCKED HIS ARMS IN AN ATTEMPT TO DEFEAT ARREST. AFTER A SHORT STRUGGLE, AOS SUCCESSFULLY PLACED OFFENDER INTO CUSTODY. AOS SEARCHED OFFENDER AND TRANSPORTED TO 007TH DISTRICT FOR PROCESSING. UPON ARRIVAL, OFFENDER REFUSING TO EXIT THE VEHICLE AND GOING LIMP / DEAD WEIGHT SEVERAL TIMES. AOS ABLE TO GAIN CONTROL OF OFFENDER, SEARCH HIS PERSON FOR CONTRABAND AND PHYSICALLY CARRY HIM INTO THE 007TH DISTRICT STATION. IN LOCK UP, OFFENDER REFUSED TO GO IN HANDCUFFS DURING BOOKING PROCEDURES. AS AOS COLEMAN, MCAULIFFE, AND WOJTACZKA ATTEMPTED TO CUFF OFFENDER TO THE PROCESSING BOOTH OFFENDER TIGHTENED AND INTERLOCKED HIS ARMS IN AN ATTEMPT TO DEFEAT CUFFING. AS AO WOJTACZKA LEANED IN TO REGAIN HIS BALANCE, OFFENDER ATTEMPTED TO GRAB AO WOJTACZKA BY THE NECK PLACING THE OFFICER IN FEAR OF RECEIVING A BATTERY. AOS EVENTUALLY ABLE TO SUCCESSFULL CUFF OFFENDER AND CONDUCT ANOTHER SEARCH OF HIS PERSON FOR WEAPONS AND/OR CONTRABAND. DURING PROCESSING, OFFENDER WHILE HANDCUFFED IN THE PROCESSING BOOTH, PROJECTILE SPIT BODILY FLUIDS AT AO BANDOLA. DUE TO OFFENDER BEHAVIOR, AOS EXPEDITED THE OFFENDER TO IMMEDIATE LOCKUP. OFFENDER REFUSED TO MOVE FROM HIS POSITION. AOS ABLE TO GET OFFENDER TO HIS FEET. OFFENDER INTENTIONALLY FELL TO THE FLOOR AND WENT DEAD WEIGHT REFUSING TO MOVE. AOS ABLE TO HANDCUFF OFFENDER AND PHYSICALLY CARRY HIM TO THE LOCKUP. AOS CONDUCTED ANOTHER SEARCH BEFORE LOCKING THE OFFENDER IN CELL NUMBER 09. WHILE IN LOCKUP, OFFENDER MANAGED TO GAIN POSSESSION OF A LIGHTER AND SET FIRE TO HIS T-SHIRT CAUSING THE LOCKUP AREA TO FILL WITH SMOKE THEREBY ENDANGERING THE LIVES OF THE OTHER LOCKUP PRISONERS. FIRE EXTINGUISHED. AOS OBSERVED OFFENDER SITTING SHIRTLESS ON THE FLOOR OF CELL 09 HOLDING A YELLOW "BIC" LIGHTER. AOS SECURED SAID YELLOW "BIC" LIGHTER AND INVENTORIED THE ITEM. AOS OBSERVED A CHARRED PIECE OF CLOTH IN CELL 09 WHICH WAS OCCUPIED BY OFFENDER. OFFENDER TRANSPORTED TO HOLY CROSS HOSPITAL BY CFD AMB 75. WHILE IN CFD AMB 75, OFFENDER MADE A SPONTANEOUS ADMISSION TO CFD BATTALION CHIEF STATING "I TOOK OFF MY CLOTHES AND SET THEM ON FIRE". OFFENDER IS NOT ON PAROLE, IS CLEAR OF ANY WANTS, WARRANTS OR ALERTS AND IS CLEAR IN GIPP AND TRAP.
