

EVENT#12947 IN SUMMARY A/O'S RESPOND TO A NEIGHBOR DISTURBANCE AT THE ABOVE LOCATION. UPON ARRIVAL A/O'S WERE MET BY [REDACTED] (VICTIM AND COMPLAINANT) WHO RELATED THAT A VERBAL ALTERCATION TOOK PLACE OVER A FENCE THAT WAS BEING BUILT IN BETWEEN BOTH PROPERTIES. [REDACTED] FURTHER RELATED THAT CESAR CARRIZALEZ(OFFENDER) CAME OUT OF HIS HOUSE SCREAMING AND STARTED TO TEAR DOWN THE FENCE THAT WAS BUILT. CESAR CARRIZALEZ THEN BEGAN TO CHARGE WITH CLOSE FIST TOWARDS [REDACTED] AND STATED " YOU MOTHER FUCKER IM GOING TO FUCKING KICK YOUR ASS YOU PIECE OF SHIT WETBACK YOU FUCKING IMMIGRANT YOU NEED TO GO BACK TO YOUR COUNTRY" THEREFORE PLACING [REDACTED] IN FEAR OF RECEIVING A BATTERY. [REDACTED] (WITNESS) RELATED THAT HE OBSERVED WHEN CESAR CARRIZALEZ(OFFENDER) ATTEMPTED TO HIT [REDACTED] WITH A CLOSE FIST AND IMMEDIATLY CALLED 911. A/O'S TOURED THE AREA AND OBSERVED CESAR CARRIZALEZ IN THE ALLEY HOLDING HIS 1 YR OLD SON IN HIS ARMS. A/O'S ATTEMPTED TO PLACE CESAR CARRIZALEZ INTO CUSTODY BUT WOULD NOT COMPLY WITH A/O'S VERBAL DIRECTION. A/O'S ATTEMPTED TO PLACE INTO CUSTODY WHEN CESAR CARRIZALEZ SHOVED PO YANEZ WITH HIS ARM AND SCRATCHED HIM WITH HIS NAILS. PO YANEZ AND PO GUZMAN CONDUCTED EMERGENCY HANDCUFFING AND STUNS TO PLACE CESAR CARRIZALEZ INTO CUSTODY. 820 ON SCENE ASSISTED WITH PLACING CESAR CARRIZALEZ INTO CUSTODY. WHILE PLACING CESAR CARRIZALEZ INTO THE BACK OF THE PATROL CAR, P.O YANEZ HELD THE DOOR OPEN THEN CESAR CARRIZALEZ KICKED PO YANEZ ON HIS FOREARM CAUSING P.O YANEZ TO HIT HIS ELBOW ON THE DOOR CAUSING A MINOR SCRAPE AND SWELLING TO P.O YANEZ. ABOVE SUBJECT TRANSPORTED TO THE 008TH DISTRICT FOR PROCESSING. NAME CHECK CLEAR NO WANTS/NO WARRANTS/ NOT ON PROBATION OR PAROLE/ NO SECOND DEGREE OF ASSOCIATION/ NO GANG CARD ON FILE/ TRAP AND GIPP CLEARED. VIN GIVEN. TRR'S COMPLETED.
