NARRATIVE

IN SUMMARY, UNK(OFFENDER) ENTERED FIRM MCDONALDS (VICTIM) AND ORDERED A NUMBER 1 MEAL. AS [REDACTED] (COMPLAINANT)(MANAGER) WAS LOOKING DOWN TO CHARGE OFFENDER, OFFENDER PULLED A DARK COLORED HAND GUN. OFFENDER ORDERED [REDACTED] TO GIVE HIM THE MONEY. AS THAT WAS GOING ON [REDACTED] (VICTIM AND COMPLAINANT) WAS ON THE PHONE WITH A FRIEND SHE STATED TO THE FRIEND "IF I HANG UP YOU HAVE TO CALL THE POLICE". AT THAT TIME OFFENDER SPOTTED [REDACTED] (VICTIM AND COMPLAINANT) HE TOLD HER GET OVER TO THE COUNTER. [REDACTED] WENT TO THE COUNTER WITH OFFENDER. OFFENDER SAID TO [REDACTED] "GIVE ME THE MONEY OR I'LL WASTE HER" ACCORDING TO [REDACTED] GAVE HIM THE MONEY \$400.00 USC. OFFENDER TOLD [REDACTED] TO GIVE HIM HER MONEY SHE HANDED OVER HER WALLET WITH \$20 USC & BANK CARD. OFFENDER THEN FLED WEST BOUND ON IRVING PARK, AND SOUTH BOUND ON AN UNK SIDE STREET. OFFENDER WAS IN A BLACK LINCOLN TOWNCAR THAT DISPLAYED A REAR BUMPER STICKER. BOTH [REDACTED] AND [REDACTED] THINK THEY CAN ID THE OFFENDER.
