NARRATIVE

EVENT #17264 IN SUMMARY, R/OS RESPONDED TO A PERSON CALLING FOR HELP IN THE GARAGE AT ABOVE ADDRESS. AS R/OS ARRIVED ON SCENE, R/OS HEARD A FEMALE VOICE FROM INSIDE THE GARAGE SCREAMING, "GET OFF ME! HELP! STOP! I JUST WANT TO GO HOME! LET ME GO! SOMEBODY HELP ME!" A MALE VOICE REPLIED, "YOU AIN'T GOING NOWHERE." IN FEAR FOR THE SAFETY OF THE FEMALE, R/O'S KNOCKED AND ANNOUNCED THEIR OFFICE AND THEN MADE FORCIBLE ENTRY INTO THE GARAGE AND OBSERVED FRANK VASQUEZ(OFFENDER & EX-BOYFRIEND) ON TOP OF [REDACTED] (VICTIM AND COMPLAINANT), WHO WAS ON THE GROUND WITH VASQUEZ PHYSICALLY RESTRAINING [REDACTED] VASQUEZ AND [REDACTED] WERE THE ONLY PEOPLE INSIDE SAID GARAGE. R/OS THEN ATTEMPTED TO PLACE VASQUEZ IN CUSTODY WHEN HE BECAME AN ASSAILANT BY SWINGING HIS CLOSED FISTS AT P.O. FRY, CAUSING P.O. FRY TO DEPLOY HIS ASP BATON TO GAIN CONTROL OF THIS ASSAILANT. AN EMERGENCY TAKEDOWN WAS CONDUCTED AND VASQUEZ, ACTING AS AN ACTIVE RESISTER, WAS PULLING AWAY AND SWINGING HIS ARMS IN AN ATTEMPT TO DEFEAT THE ARREST. P.O. LOBIANCO DELIVERED OPEN HAND STRIKES AND P.O. FRY USED ARM BAR AND WRIST LOCK TECHNIQUES AND WAS ABLE TO PLACE VASQUEZ IN CUSTODY. DURING THIS STRUGGLE, VASQUEZ SUFFERED AN INJURY TO HIS RIGHT EYE, WAS TRANSPORTED TO TRINITY HOSPITAL BY BEAT 432 WHERE HE WAS TREATED AND RELEASED BY DR. PATEL. [REDACTED] THEN RELATED TO R/OS THAT SHE AND VASQUEZ WERE DATING, BROKE UP APPROXIMATELY ONE WEEK AGO AND WERE ATTEMPTING TO RECONCILE. VASQUEZ PICKED UP [REDACTED] FROM [REDACTED] AND SHORTLY AFTER ENGAGED IN A VERBAL ALTERCATION IN VASQUEZ'S CAR. VASQUEZ DEMANDED TO SEE [REDACTED]'S PHONE AND FORCIBLY TOOK SAID PHONE FROM [REDACTED], ACCUSING [REDACTED] OF SEEING OTHER PEOPLE. THE ARGUMENT CONTINUED AS THEY ENTERED VASQUEZ'S GARAGE, WHERE VASQUEZ TOOK [REDACTED]'S BAG FROM HER, PUSHING HER TO THE GROUND- RESULTING IN [REDACTED] STRIKING THE LEFT SIDE OF HER HEAD ON THE CONCRETE FLOOR. [REDACTED] THEN ATTEMPTED TO OPEN THE GARAGE DOOR TO LEAVE SEVERAL TIMES WITH VASQUEZ CLOSING THE DOOR AND FINALLY HOLDING [REDACTED] ON THE GROUND, FORCIBLY RESTRAINING HER IN AN EFFORT TO PREVENT HER FROM LEAVING THE GARAGE. R/OS NOTIFIED A/S SVU DET. ASHFORD @ 2300 HOURS VIA PAX. [REDACTED] FURTHER STATED THAT SHE WISHED TO PURSUE FELONY CHARGES AGAINST VASQUEZ. TRRS COMPLETED.
