**NARRATIVE**

EV #15890 IN SUMMARY, RO'S RESPONDED TO A 10-1 AT 83RD ST AND KERFOOT. UPON ARRIVAL RO'S DISCOVERED BT 622, PO'S MORSI #4176 AND LOPEZ #11943 CONDUCTED A TRAFFIC STOP IN THE ALLEY OF 8310 S. KERFOOT. AS BT 622 PROCEEDED SOUTHBOUND IN WEST ALLEY OF KERFOOT, A 2009 WHITE LEXUS ES350 (IL REG [REDACTED] DROVE NORTHBOUND, NOT ALLOWING BT 622 TO PASS. THE LEXUS THEN HONKED ITS HORN AND SHINED ITS HIGH BEAM LIGHTS AT BT 622. BT 622 THEN EXITED THEIR MARKED VEHICLE. (VICTIM) BT 622 PO MORSI #4176 REPEATEDLY ASKED FOR OFFENDER #1'S DRIVER'S LICENSE AND INSURANCE INFORMATION. BROWN REPEATEDLY REFUSED TO COMPLY AND CONTINUALLY MADE MOVEMENTS UNDERNEATH HER SEAT. DURING THE STOP, [REDACTED] (OFFENDER) [REDACTED], AND THEN BY DRIVER, CATHERINE BROWN(OFFENDER) FROM INSIDE THE VEHICLE. AT THIS TIME BROWN, CATHERINE GRABBED HOLD OF VICTIM'S VEST AND HELD IT. BROWN THEN PLACED HER VEHICLE IN REVERSE WHILE STILL HOLDING ONTO VICTIM, DRAGGING HER ALONG WITH THE VEHICLE APPROXIMATELY 50 FEET. VICTIM MORSI SUFFERED INJURIES WHILE BEING DRAGGED AND BROKE FREE. BT 622 PO LOPEZ PURSUED ON FOOT, WHILE CALLING FOR ASSIST UNITS. VICTIM (PO MORSI) RETURNED TO HER MARKED VEHICLE AND PURSUED BROWN, WHOSE VEHICLE WAS STILL IN REVERSE, ONTO THE STREET SIDE OF KERFOOT. BROWN THEN STRUCK A PARKED VEHICLE (SEE IL TRAFFIC CRASH REPORT RD #HW273163) AND ATTEMPTED TO FLEE SCENE. MORSI PROCEEDED FORWARD, BLOCKING BROWN FROM FLEEING. BROWN WAS PLACED INTO CUSTODY. VICTIM PO MORSI WAS TRANSPORTED TO NORTHWESTERN HOSPITAL BY CFD #16. MORSI WAS TREATED AND RELEASED BY DR. ALDEEN. OFFENDERS #1 AND #2 WERE TRANSPORTED TO LCM HOSPITAL BY CFD #30. OFFENDER #1 WAS TREATED AND RELEASED BY ER DR. MAMDANI AND REFUSED TREATMENT FOR OFFENDER #2.EVIDENCE TECHNICIAN REQUESTED FOR VICTIM'S INJURIES AND CRIME SCENE. A/SOUTH VIOLENT CRIMES BT. 5232 ONSCENE. OEMC GALON NOTIFIED AT 2155 HRS.BTS 643, 672, AND 652 SECURED CRIME SCENE.BTS 690, 600, 621, 610, 620, 630, 650, 4250, 4511 ON SCENE. CB 18658106.
