SYNOPSIS OF ORIGINAL CASE REPORT NARRATIVE:

R/O'S RESPONDED TO A NEIGHBOR DISTURBANCE AT THE ABOVE LOCATION. UPON ARRIVAL A/O'S WERE MET BY [REDACTED] (VICTIM AND COMPLAINANT) WHO RELATED THAT A VERBAL ALTERCATION TOOK PLACE OVER A FENCE THAT WAS BEING BUILT BETWEEN BOTH PROPERTIES. [REDACTED] FURTHER RELATED THAT CESAR CARRIZALEZ (OFFENDER) CAME OUT OF HIS HOUSE SCREAMING AND STARTED TO TEAR DOWN THE FENCE THAT WAS BUILT. CESAR CARRIZALEZ THEN BEGAN TO CHARGE WITH CLOSE FIST TOWARDS [REDACTED] AND STATED "YOU MOTHER FUCKER IM GOING TO FUCKING KICK YOUR ASS YOU PIECE OF SHIT WETBACK YOU FUCKING IMMIGRANT YOU NEED TO GO BACK TO YOUR COUNTRY" THEREFORE PLACING [REDACTED] IN FEAR OF RECEIVING A BATTERY. [REDACTED] (WITNESS) RELATED THAT HE OBSERVED WHEN CESAR CARRIZALEZ (OFFENDER) ATTEMPTED TO HIT HIS SON WITH A CLOSE FIST AND IMMEDIATLY CALLED 911. R/O'S TOURED THE AREA AND OBSERVED CESAR CARRIZALEZ IN THE ALLEY HOLDING HIS 1 YR OLD SON IN HIS ARMS. A/O'S ATTEMPTED TO PLACE CESAR CARRIZALEZ INTO CUSTODY BUT WOULD NOT COMPLY WITH A/O'S VERBAL DIRECTION. A/O'S ATTEMPTED TO PLACE INTO CUSTODY WHEN CESAR CARRIZALEZ SHOVED PO YANEZ WITH HIS ARM AND SCRATCHED HIM WITH HIS NAILS. PO YANEZ AND PO GUZMAN CONDUCTED EMERENCY HANDCUFFING AND STUNS TO PLACE CESAR CARRIZALEZ INTO CUSTODY. 820 ON SCENE ASSISTED WITH PLACING CESAR CARRIZALEZ INTO CUSTODY. WHILE PLACING CESAR CARRIZALEZ INTO THE BACK OF THE PATROL CAR, P.O YANEZ HELD THE DOOR OPEN THEN CESAR CARRIZALEZ KICKED PO YANEZ ON HIS FOREARM CAUSING P.O YANEZ TO HIT HIS ELBOW ON THE DOOR CAUSING A MINOR SCRAPE AND SWELLING TO P.O YANEZ. ABOVE SUBJECT TRANSPORTED TO THE 008TH DISTRICT FOR PROCESSING.

INVESTIGATION

R/D was assigned this case with offender in custody.

R/D interviewed victim in this matter, P.O. YANEZ #17142 and learned the following:

P.O. YANEZ was assigned a neighbor dispute. While attempting to place offender (CARRIZALEZ, CESAR) into custody, he became combative attempting to defeat the arrest by striking out at P.O. YANEZ scratching his right forearm. P.O. YANEZ after gaining control of offender was attempting to escort offender along with partner P.O. GUZMAN-SANCHEZ #13389 to the police vehicle. P.O. YANEZ then opened the rear door of the police vehicle when offender became violent again and started to kick P.O. YANEZ on right side of his body and in his right elbow causing P.O. YANEZ to stumble into the door of vehicle. P.O. YANEZ suffered a swollen right elbow and red contusion to said elbow. Along with an approx. 4 inch scratch to right forearm.

R/D then attempted to interview offender in this matter. Offender was extremely hostile and abusive.

R/D had assistance due to offenders' hostility, from DET. DOWLING #21018 & DET. CHOPP #21772

R/D along with DET. DOWLING #21018 & DET. CHOPP #21772 mirandized offender at 2210 hrs.

Offender refused to talk and asked for a lawyer. All questions were stopped at this time.

R/D then contacted A.S.A. M. McCurry who upon hearing the facts in this matter approved charges at 2242 hrs. on 10-OCT-2015

Based on the aforementioned information, R/D requests that this case be clear closed based on offenders arrest and pending prosecution in this matter
