NARRATIVES

EVENT # 18169 IN SUMMARY, AOS ON ROUTINE PATROL OBSERVED TWO INDIVIDUALS NOW KNOWN AS ALAN SHIELDS(OFFENDER) & KEVIN MACBRIDE(OFFENDER) LOITERING ON THE NORTH EAST CORNER OF 6900 S ASHLAND AVE FOR APPROXIMATELY 10-15 MINUTES BEFORE RELOCATING TO THE EAST ALLEY OF 6900 S ASHLAND AVE. AOS, SUSPECTING A NARCOTICS TRANSACTION IN PROGRESS, ALSO RELOCATED TO THE EAST ALLEY OF THE 6900 BLOCK OF S ASHLAND AVE. UPON VIEWING AOS IN THEIR MARKED VEHICLE BOTH OFFENDER'S BODY LANGUAGE IMMEDIATELY CHANGED IN THAT BOTH OFFENDERS ABRUPTLY STOPPED, SHIFTED THEIR WEIGHT, AND DARTED THEIR EYES AWAY FROM AO'S BEFORE BEGINNING TO WALK AGAIN. AOS APPROACHED OFFENDERS FOR A FIELD INTERVIEW. COLEMAN (VICTIM AND COMPLAINANT) ASKED ALAN SHIELDS(OFFENDER) IF HE HAD ANY WEAPONS OR CONTRABAND ON HIS PERSON. ALAN SHIELDS(OFFENDER) BECAME EXTREMELY AGGRESSIVE RAISING HIS VOICE AND USING OBSCENITIES. COLEMAN (VICTIM AND COMPLAINANT) PERFORMED A PROTECTIVE PAT DOWN AND FELT A SHARP OBJECT IN THE FRONT POCKET. COLEMAN (VICTIM AND COMPLAINANT) WENT INTO SAID POCKET,

RETRIEVED THE OBJECT AND OBSERVED IT TO BE A STEAK KNIFE WITH A STEEL HANDLE. IN LIGHT OF THIS DISCOVERY, COLEMAN (VICTIM AND COMPLAINANT) EXPLAINED TO ALAN SHIELDS(OFFENDER) THAT HIS POCKETS WOULD BE SEARCHED THOROUGHLY FOR ANY OTHER WEAPONS. AS COLEMAN (VICTIM AND COMPLAINANT) REACHED FOR ALAN SHIELDS(OFFENDER) POCKET, ALAN SHIELDS(OFFENDER) KNOWINGLY AND INTENTIONALLY MADE PHYSICAL CONTACT WITH THE OFFICER IN THAT HE FORCEFULLY GRABBED COLEMAN (VICTIM AND COMPLAINANT) BY THE WRIST AND SHOVED HIM AWAY IN AN AGGRESSIVE MANNER. COLEMAN (VICTIM AND COMPLAINANT) PLACED ALAN SHIELDS(OFFENDER) IN A WRISTLOCK AND ATTEMPTED TO PLACE THE OFFENDER INTO CUSTODY. ALAN SHIELDS(OFFENDER) TIGHTENED HIS GRIP AND INTERLOCKED HIS ARMS IN AN ATTEMPT TO DEFEAT ARREST. AFTER A SHORT STRUGGLE, AOS SUCCESSFULLY PLACED ALAN SHIELDS(OFFENDER) INTO CUSTODY AT 2327 HOURS. SUBSEQUENTLY, AOS PERFORMED A PROTECTIVE PAT DOWN ON KEVIN MACBRIDE(OFFENDER) AND DISCOVERED ONE HYPODERMIC SYRINGE. KEVIN MACBRIDE(OFFENDER) EXPLAINED TO AOS THAT HE HAD THE SYRINGE IN HIS POSSESSION BECAUSE HE HAD RECENTLY USED HEROIN AND WAS PLANNING ON USING HEROIN AGAIN IN THE NEAR FUTURE. KEVIN MACBRIDE(OFFENDER) PLACED INTO CUSTODY AND TRANSPORTED TO 007TH DISTRICT FOR PROCESSING BY BEAT 0713R. AOS SEARCHED ALAN SHIELDS(OFFENDER), SECURED HIS BELONGINGS AND TRANSPORTED THE OFFENDER TO 007TH DISTRICT FOR PROCESSING. UPON ARRIVAL, ALAN SHIELDS(OFFENDER) WAS EXTREMELY UNCOOPERATIVE GOING INTO THE STATION LOCK UP BY REFUSING TO EXIT THE VEHICLE AND GOING LIMP / DEAD WEIGHT SEVERAL TIMES. AOS ABLE TO GAIN CONTROL OF ALAN SHIELDS(OFFENDER), SEARCH HIS PERSON FOR CONTRABAND AND PHYSICALLY CARRY HIM INTO THE 007TH DISTRICT STATION. AT THIS TIME AO COLEMAN RETURNED TO THE MARKED VEHICLE TO SEARCH THE CAGE FOR ANY CONTRABAND LEFT BEHIND BY THE OFFENDER. SEARCH RETURNED NEGATIVE RESULTS. IN LOCK UP, ALAN SHIELDS(OFFENDER) REFUSED TO GO IN HANDCUFFS DURING BOOKING PROCEDURES. AS AOS COLEMAN, MCAULIFFE, AND WOJTACZKA ATTEMPTED TO CUFF ALAN SHIELDS(OFFENDER) TO THE PROCESSING BOOTH ALAN SHIELDS(OFFENDER) TIGHTENED AND INTERLOCKED HIS ARMS IN AN ATTEMPT TO DEFEAT CUFFING. AS AO WOJTACZKA LEANED IN TO REGAIN HIS BALANCE, ALAN SHIELDS(OFFENDER) ATTEMPTED TO GRAB AO WOJTACZKA BY THE NECK PLACING THE OFFICER IN FEAR OF RECEIVING A BATTERY. AOS ABLE TO SUCCESSFULL DETAIN ALAN SHIELDS(OFFENDER) AND CONDUCT ANOTHER SEARCH OF HIS PERSON FOR WEAPONS AND/OR CONTRABAND. DURING PROCESSING, ALAN SHIELDS(OFFENDER) CONTINUED TO BE UNCOOPERATIVE AND COMBATIVE. ALAN SHIELDS(OFFENDER), WHILE HANDCUFFED IN THE PROCESSING BOOTH, PROJECTILE SPIT BODILY FLUIDS AT AO BANDOLA. DUE TO ALAN SHIELDS(OFFENDER) UNRULY NATURE, AOS EXPEDITED THE OFFENDER TO IMMEDIATE LOCKUP. AGAIN, ALAN SHIELDS(OFFENDER) REMAINED UNCOOPERATIVE BY REFUSING TO MOVE FROM HIS POSITION. AS AOS ABLE TO GET ALAN SHIELDS(OFFENDER) TO HIS FEET ALAN SHIELDS(OFFENDER) INTENTIONALLY FELL TO THE FLOOR AND WENT DEAD WEIGHT REFUSING TO MOVE. AOS COLEMAN, MCAULIFFE, WOJTACZKA, SGT. JOSEPHS, AND LT. WIBERG EVENTUALLY ABLE TO HANDCUFF ALAN SHIELDS(OFFENDER) AND PHYSICALLY CARRY HIM TO THE LOCKUP. AOS CONDUCTED ANOTHER SEARCH BEFORE LOCKING THE OFFENDER IN CELL NUMBER 09. WHILE IN LOCKUP, ALAN SHIELDS(OFFENDER) MANAGED TO GAIN POSSESSION OF A LIGHTER AND SET FIRE TO HIS T-SHIRT CAUSING THE LOCKUP AREA TO FILL WITH SMOKE THEREBY ENDANGERING THE LIVES OF THE OTHER LOCKUP PRISONERS. FIRE EXTINGUISHED BY SGT. JOSEPHS VIA WALL MOUNTED FIRE EXTINGUISHER IN THE LOCKUP AREA AT 0100 HOURS. UPON EXTINGUISHING THE FIRE, AOS OBSERVED ALAN SHIELDS(OFFENDER) SITTING SHIRTLESS ON THE FLOOR OF CELL 09 HOLDING A YELLOW "BIC" LIGHTER. AO MCAULIFFE SECURED SAID YELLOW "BIC" LIGHTER AND INVENTORIED THE ITEM. AOS OBSERVED A CHARRED PIECE OF CLOTH IN CELL 09 WHICH WAS OCCUPIED BY ALAN SHIELDS(OFFENDER). AOS IMMEDIATELY SECURED PRISONERS AND RELOCATED THEM TO A SECURE AREA AWAY FROM SMOKE. CFD AMBULANCE 75 ON SCENE. CFD BATTALION 19 ON SCENE. CFD OFFICE OF FIRE INVESTIGATIONS 466 ON SCENE. ALAN SHIELDS(OFFENDER) TRANSPORTED TO HOLY CROSS HOSPITAL BY CFD AMB 75. WHILE IN CFD AMB 75, ALAN SHIELDS(OFFENDER) MADE A SPONTANEOUS ADMISSION TO CFD BATTALION CHIEF CROOKER STATING "I TOOK OFF MY CLOTHES AND SET THEM ON FIRE". BOMB AND ARSON DETECTIVES NOTIFIED. DETECTIVE LIGUORI ON SCENE. ALAN SHIELDS(OFFENDER) IS NOT ON PAROLE, IS CLEAR OF ANY WANTS, WARRANTS OR ALERTS AND IS CLEAR IN GIPP AND TRAP. NAME CHECK OF KEVIN MACBRIDE(OFFENDER) REVEALED AN ACTIVE WARRANT #W13K2661. KEVIN MACBRIDE(OFFENDER) INITIALLY GAVE AOS SEVERAL FAKE NAMES. KEVIN MACBRIDE(OFFENDER) STATED THAT HE INTENTIONALLY OBSTRUCTED HIS IDENTIFICATION BECAUSE HE KNEW HE HAD A WARRANT FOR HIS ARREST. KEVIN MACBRIDE(OFFENDER) IS NOT ON PAROLE AND IS CLEAR IN GIPP AND TRAP.
