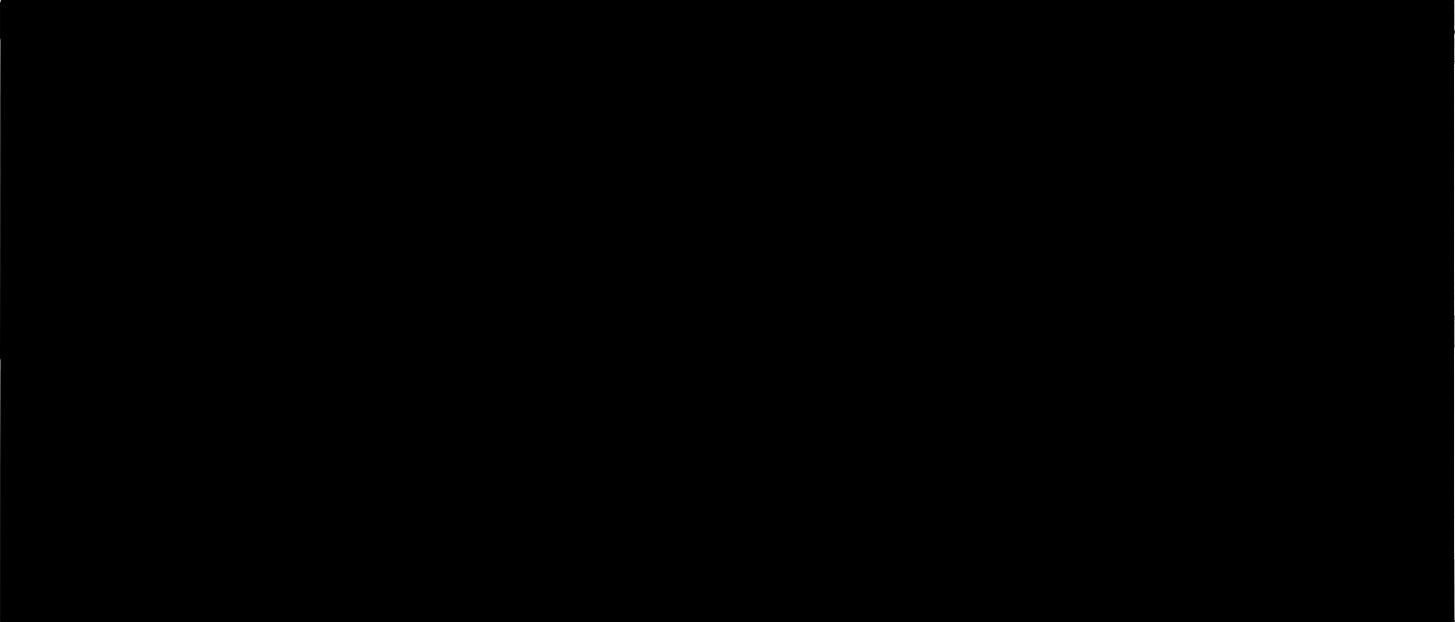

NARRATIVES

(EVENT #10897) IN SUMMARY, AO'S RESPONDED TO A MAN WITH A GUN CALL AT 50TH AND WABASH. DISPATCH RELATED THAT AN OFF DUTY CHICAGO POLICE SGT. PENDARVIS #1937 (WITNESS) ON-VIEWED A MAROON/RED CHEVY MISSING A BUMPER OCCUPIED AT LEAST TWICE WITH MALE BLACKS WITH DREADS DRIVING IN TRAFFIC. [REDACTED]

[REDACTED] R/O'S BEGAN TO TOUR THE AREA OF THE LAST KNOWN LOCATION OF VEHICLE (50TH AND WABASH). WHILE R/OS TOURED AREA, AT APPROXIMATELY 43RD AND STATE, AO'S OBSERVED VEHICLE THAT MATCHED THE DESCRIPTION GIVEN FROM FLASH MESSAGE. AO'S PULLED BEHIND A MAROON CHEVROLET EQUINOX MISSING A BUMPER OCCUPIED AT LEAST TWICE WITH A MALE PASSENGER WHO HAD DREADS AT THE BP GAS STATION AT 43RD AND STATE. SAID VEHICLE THEN ACCELERATED AT A HIGH RATE OF SPEED GOING NORTHBOUND ON STATE ST AND A BRIEF PURSUIT ENSUED AND EMERGENCY EQUIPMENT WAS ACTIVATED. AT APPROXIMATELY 20 E. 42ND ST, THE OFFENDERS VEHICLE STRUCK A BLACK INFINITI ([REDACTED]). REPORT FOR ACCIDENT UNDER HZ317472. R/O'S IMMEDIATELY WERE ON SCENE WITH BEAT 225 AND CALLED DISPATCH FOR MULTIPLE AMBULANCES. VICTIMS OF BLACK INFINITI WERE [REDACTED] (MOTHER) AND [REDACTED] (SON). BOTH OF THOSE VICTIMS WERE TAKEN TO STROGER WITH MINOR INJURIES. TREATED BY ATTENDING PHYSICIAN DR. KAMINSKY AND LISTED IN



GOOD CONDITION. THERE WERE THREE OFFENDERS INSIDE MAROON CHEVROLET EQUINOX WITH PLATES [REDACTED] THAT FLED FROM R/O'S. A LEADS INQUIRY REVEALED THAT CAR WAS STOLEN UNDER RD # HZ315230. REAR PASSENGER, AMARI CATCHINGS(OFFENDER) WAS PRONOUNCED DOA ON SCENE BY CFD 35 AT 1657 HRS. THE DRIVER OF THE VEHICLE, LATER TO BE IDENTIFIED AS DOMINIC GIBSON(OFFENDER), WAS OBSERVED BY R/O'S TO BE PARTIALLY STILL IN THE DRIVERS SEAT ON R/O'S ARRIVAL AND ATTEMPTING TO EXIT THE VEHICLE FROM THE DRIVERS SIDE DOOR. PENDARVIS (COMPLAINANT) ALSO IDENTIFIED CRASHED VEHICLE AS THE VEHICLE USED IN THE AGGRAVATED ASSAULT. GUN DESK NOTIFIED UNDER #13712217, GUN CLEARED AND NOT REGISTERED. WEAPON WAS RECOVERED BY E.T. NORRIS #19686 BEAT 5843 ON SCENE. VEHICLE WAS TAKEN INTO CUSTODY BY MAIU, MAIU CACCIATORE #7157 BEAT 5797 ON SCENE. ALL OFFENDERS AND VICTIMS WERE TRANSPORTED TO STROGER (COOK COUNTY HOSPITAL) AND TREATED BY ATTENDING PHYSICIAN DR. KAMINSKY. BOTH OFFENDERS DOMINIC GIBSON(OFFENDER) AND [REDACTED] (OFFENDER) WERE ADMITTED TO HOSPITAL OVER NIGHT AND AT THE TIME OF THIS REPORT LISTED IN STABLE CONDITION. [REDACTED]
