Police Officer SCOTT gave several verbal commands for offender (WHITE) to cease his actions. After offender (WHITE) refused to comply with Officer SCOTT's verbal commands and officer SCOTT fearing for his safety and the safety of his fellow officers discharged two rounds from his duty weapon striking offender (WHITE). Offender (white) was immediately placed into custody and Mirandized. CFD was immediately summoned for medical treatment offender (white) and was then transported to Stroger Hospital by CFD ambulance #10.
