AT OFFICER'S ARRIVAL OFFENDER BRANDISHED, WHAT WAS LATER DISCOVERED TO BE, A BB-GUN AT OFFICERS KEARNS 17680, AND DELGADO FERNANDEZ, THUS CAUSING THEM TO BE IN REASONABLE FEAR OF RECEIVING A BATTERY. DURING THE EVENT THE OFFENDER SUSTAINED A GUNSHOT WOUND TO THE LOWER RIGHT LEG AND TASER CONTACT (CARTRIDGE INVENTORY#13725431), AFTERWHICH HE WAS PLACED INTO CUSTODY.
