EVENT #13102 RESPONDING TO A CALL OF A ROBBERY IN PROGRESS, A/O'S OBSERVED OFFENDER EXIT A REAR, BASEMENT STAIRWAY AT LISTED ADDRESS AND RAISE A BLACK FIREARM IN PO SCHMIDT'S DIRECTION. IN FEAR OF HIS LIFE, PO SCHMIDT FIRED TWO (2) ROUNDS STRIKING OFFENDER BOTH TIMES ABOUT THE BODY CAUSING OFFENDER TO FALL TO THE GROUND, DROPPING SAID FIREARM. OFFENDER PLACED IN CUSTODY, TRANSPORTED TO COOK COUNTY HOSPITAL BY CFD FOR TREATMENT. ON SCENE, VICTIM RELATED TO A/O'S THAT OFFENDER CHASED HIM THROUGH THE REAR LOT OF LISTED ADDRESS, TRAPPING HIM INSIDE THE REAR, BASEMENT STAIRCASE WHERE OFFENDER PLACED A HANDGUN AGAINST HIS HEAD AND REMOVED USC AND A CELL PHONE FROM VICTIM'S POCKETS. FIREARM PRESERVED FOR PRINTS, RECOVERED BY RESPONDING ET ON SCENE. HANDGUN RECOVERED ON SCENE IDENTIFIED BY VICTIM AS THE SAME THAT OFFENDER USED IN ABOVE ROBBERY. CUSTODIAL SEARCH OF OFFENDER REVEALED SIX (6) CLEAR, KNOTTED, PLASTIC BAGGIES, EACH CONTAINING A WHITE ROCK LIKE SUBSTANCE, SUSPECT CRACK COCAINE LATER INVENTORIED UNDER #13736801, \$300 USC LATER INVENTORIED UNDER #13736783 AND A WHITE CELL PHONE IN A BLACK CASE LATER INVENTORIED UNDER #13736793. OFFENDER NAME CHECK CLEAR, OFFENDER IS A COVICTED FELON, NOT ON PAROLE, NOT ON GIPP/TRAP AND NEGATIVE RESULTS CSII SEARCH.
