Victim, Police Officer, responding to citizens shot under RD# HZ-339436, observed (2) subjects near the location of rival gang members. The victim, Police Officer, attempted to stop above subject for a field interview after observing an object protruding from the subject's pant pocket. The subject fled with the officer in pursuit. The subject produced the handgun from his pant pocket and pointed it in the direction of the officer. The officer being in fear for his life fired one time at the subject. The subject fled into an associate's apartment where he was taken into custody and the weapon was recovered.

INVESTIGATION

The Reporting Detective was assigned to the investigation of an aggravated assault to the police with a handgun against 010th District Police Officer NAVARRO #6059 at the location of 1537 S. Harding in Chicago, Illinois per Sgt. Rajkovich #2193 of this command. Reporting Detective learned that one subject was in custody and that a handgun was recovered.

Reporting Detectives immediately relocate to the location of 1537 S. Harding and observe numerous police personnel and vehicles at that location. Yellow crime scene tape extended across Harding at that location with numerous citizens standing around the crime scene tape and observing the investigation. The area of the scene consists mainly of single and multiple family residences with several vacant lots on the block at that location. 1537 S. Harding is a three story brick structure which contains three residences.

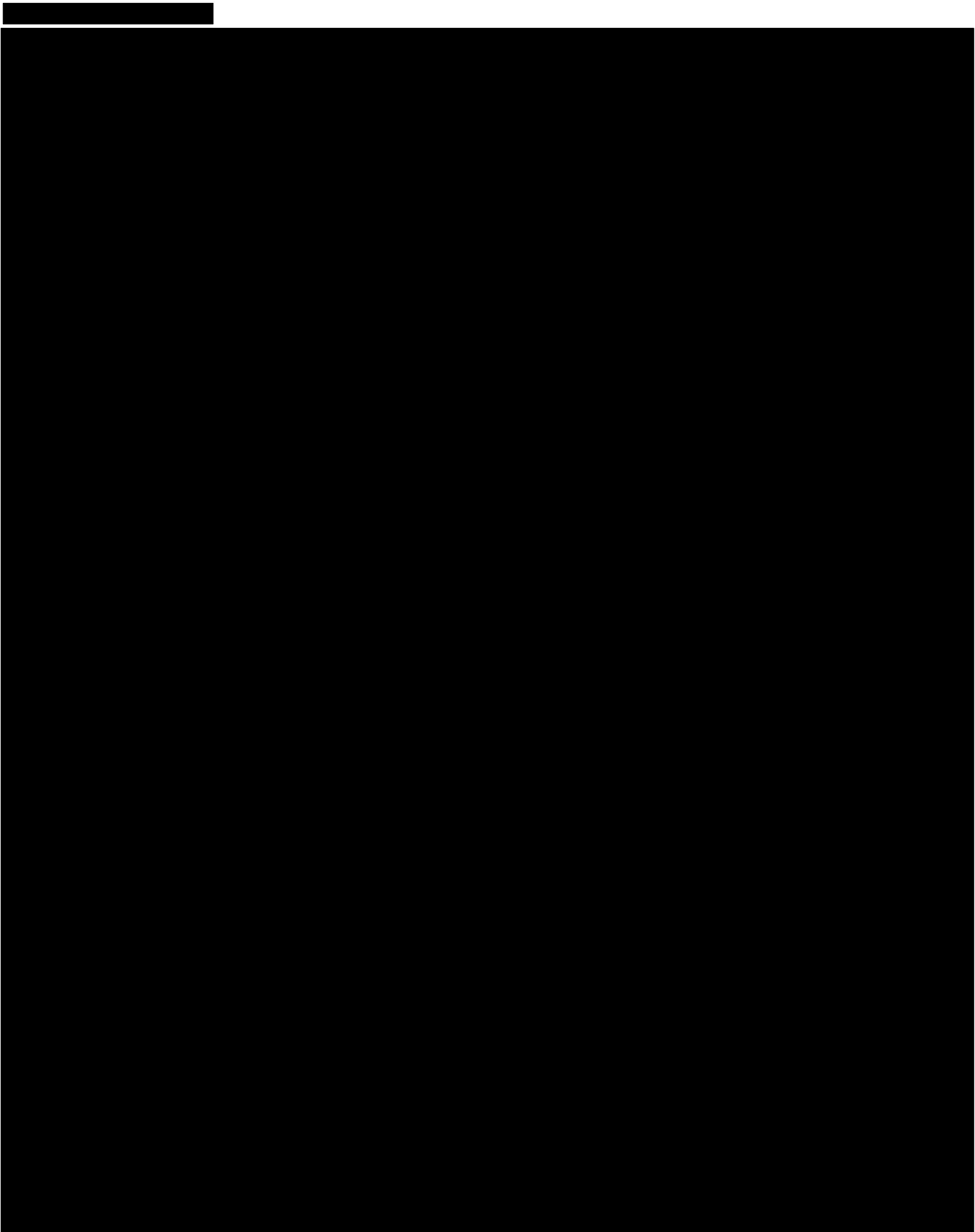
Reporting Detectives were approached by P.O. Nelson #7578 who related that he was assigned to be the paper car and would handle the general offense case report. Officer Nelson related that the officers responded to people shot. The officers came to the location of 16th and Harding and observed two male black subjects. One subject had an object partially protruding from his pocket which the victim officer described as tan and black. The officer exited his vehicle and the subject fled northbound. P.O. Nelson related that the officer was inside of the residence where the subject was taken into custody.

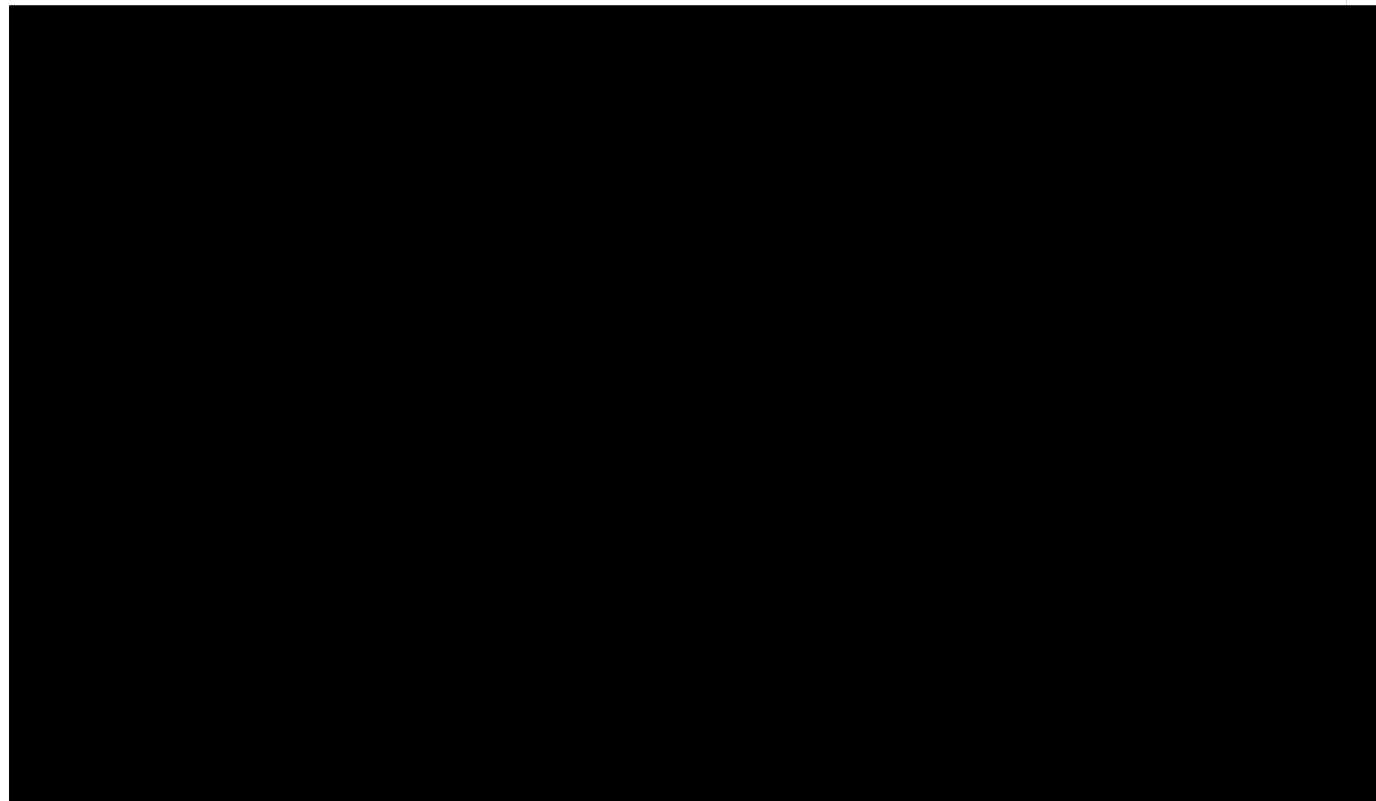
