NARRATIVES

EVENT# 05587 IN SUMMARY: P/O MARKOVICH OBSERVED OFFENDER DRINKING FROM A BOTTLE OF PAUL MASON BRANDY ON THE PUBLIC WAY IN PLAIN VIEW. THE P/O APPROACHED AT WHICH THE OFFENDER PLACED THE BOTTLE IN HIS LEFT POCKET. THE P/O ORDERED THE SUBJECT TO RELINQUISH THE SAID BOTTLE AND RELATED THAT IT WAS UNLAWFUL TO CONSUME IN PUBLIC. THIS SUBJECT HAS BEEN TOLD THIS ON NUMEROUS INSTANCES AND ADVISED THAT THIS WOULD EVENTUALLY RESULT IN ARREST AS IT DID ON TODAY'S DATE. THE SUBJECT PLACED IN CUSTODY WITHOUT INCIDENT. ENROUTE TO 020 THE OFFENDER BECAME BELIGERANT AND THREATENING TO P/O AND ADDITIONALLY THREATENING TO KILL THE P/O'S ENTIRE FAMILY. THE P/O CALLED FOR 2052 TO ASSIST HIM WITH THE SUBJECT'S PROCESSING SINCE HIS Demeanor WAS THREATENING. UPON ARRIVAL TO 020 THE SUBJECT WAS ESCORTED FROM THE VEHICLE TO THE ENTRY-WAY INTO THE PROCESSING AREA AND WHILE P/O WAS KEYING IN THE DOOR FOR THE AREA THE SUBJECT ELBOWED THE P/O TO THE LEFT RIB CAGE AREA WITH HIS RIGHT ELBOW. THE P/O CONTINUED TO ESCORT THE SUBJECT INTO THE PROCESSING AREA AND WHEN THE OFFENDER WAS AT THE DOORWAY OF THE DETENTION CELL HE STIFFENED AND STOPPED. AS P/O WAS ATTEMPTING TO GET HIM INTO THE AREA TO SECURE HIM AND CONDUCT A PROPER CUSTODIAL SEARCH THE SUBJECT FELL FORWARD TO THE FLOOR STRIKING HIS FOREHEAD. P/O SECURED CFD TO RENDER AID. CFD 40 ARRIVED AND ASCERTAINED THAT DUE TO HIS DIABETES AND VERY HIGH SUGAR LEVEL THAT HE NEEDS TO BE TRANSPORTED TO ST FRANCIS FOR TREATMENT.
