NARRATIVE

EVENT #03593 IN SUMMARY - P.O. CALDERON (VICTIM) STATED THAT WHILE LEAVING WORK IN HIS PERSONAL VEHICLE, VICTIM EXITED POLICE STATION PARKING LOT AND TRAVELED N/B IN THE WEST ALLEY OF HALSTED STREET BEHIND THE 009TH DISTRICT POLICE STATION. VICTIM THEN STATED THAT HE STOPPED AT THE MOUTH OF THE ALLEY BEFORE ENTERING 31ST STREET TO MAKE SURE CROSS TRAFFIC WAS CLEAR. AT THIS TIME VICTIM OBSERVED A LIGHT BROWN MINIVAN (BELIEVED TO BE A GRAND CARAVAN PER VICTIM), WITH A MALE BLACK DRIVER AND A MALE WHITE PASSENGER IN THE REAR OF THE MINIVAN PARKED FACING W/B ON THE NORTH SIDE OF 31ST STREET. UPON VICTIM MAKING A LEFT HAND TURN W/B ON 31ST STREET, THE BROWN MINIVAN SPED IN FRONT OF VICTIM'S VEHICLE. APPROXIMATELY A BLOCK WEST ON 31ST STREET THE BROWN MINIVAN PULLED OVER ALLOWING VICTIM'S VEHICLE TO PASS, AT WHICH TIME THE BROWN MINIVAN BEGAN FOLLOWING VICTIM'S VEHICLE. VICTIM THEN SPED UP IN ATTEMPT TO INSURE HE WAS BEING FOLLOWED, WHICH RESULTED IN OFFENDER'S VEHICLE SPEEDING UP TO CATCH UP TO VICTIM. VICTIM THEN PROCEEDED TO TRAVEL W/B ON 31ST AND TRAVELED THROUGH THE INTERSECTION AT MORGAN ST AGAINST THE TRAFFIC LIGHT AND WAS FOLLOWED THROUGH THE RED LIGHT OFFENDING VEHICLE DISREGARDING THE CIRCULAR RED SIGNAL. VICTIM APPROACHED 31ST STREET AND LOOMIS AVE AND CAME TO A COMPLETE STOP, AT WHICH TIME OFFENDING VEHICLE WENT INTO ONCOMING TRAFFIC LANE, GOING AROUND VICTIM'S VEHICLE. VICTIM THEN OBSERVED REAR SIDE SLIDING DOOR OPEN ON THE MINIVAN AND UNKNOWN(OFFENDER) A MALE WHITE WITH A BLACK HOODY PULLED OVER HIS HEAD AND A WHITE AND BLACK SCARF COVERING HALF HIS FACE, DISPLAYED A HANDGUN FIRING AT VICTIM. ONCE VICTIM OBSERVED THE SHOTS FIRED IN HIS DIRECTION, VICTIM OFF DUTY P.O. CALDERON RETURN FIRE, DISCHARGING HIS WEAPON. AT THIS TIME THE OFFENDING VEHICLE SPED W/B ON 31ST STREET THEN MADE A RIGHT TURN N/B ONTO PITNEY CT THEN FLED IN UNKNOWN DIRECTION. RO'S IMMEDIATELY RESPONDED TO THE SHOTS FIRED CALLS COMING IN TO DISPATCH AND FOUND P.O. CALDERON WAITING AT 31ST STREET AND LOOMIS. UPON SPEAKING WITH P.O. IT WAS DISCOVERED P.O. CALDERON HAD SUFFERED A GRAZE WOUND TO UPPER LEFT SHOULDER. CFD WAS REQUESTED AND AMBULANCE #19 ARRIVED ON SCENE. VICTIM WAS THEN RELOCATED TO NORTHWESTERN HOSPITAL FOR TREATMENT. NO BWC RECORDING AT TIME OF INCIDENT. VICTIM BELIEVES THE OFFENDING VEHICLE WAS A BROWN MINIVAN POSSIBLE DODGE GRAND CARAVAN WITH PARTIAL BEGINING ILLINOIS LICENSE PLATE V97 OR N97 AND HAD DAMAGE REPAIR (BONDO) ON THE REAR TIRE QUARTER PANEL. VICTIM IS IN STABLE CONDITION. FORMAL FLASH MADE VIA CITYWIDE PER MORRIS #100. NO FURTHER INFO AT THIS TIME.
