EVT#00833. IN SUMMARY WHILE ON PATROL, A/O'S OBSERVED ABOVE SUBJECT STANDING IN AN ALLEY HOLDING AN OBJECT IN A BROWN PAPER BAG BELIEVED TO HAVE BEEN AN ALCOHOLIC BEVERAGE. A/O'S APPROACHED FOR A FIELD INTERVIEW AT WHICH TIME OFFENDER WAS SCENE PLACING THE BROWN BAG WITH AN OBJECT INSIDE ON THE GROUND. JOHN MEDERICH(OFFENDER) STATED " I'M SORRY," AT WHICH TIME A/O ASKED "SORRY FOR WHAT?" OFFENDER THEN STATED " FOR DRINKING IN PUBLIC." A/O RELATED TO THE OFFENDER THAT HE WOULD BE RECEIVING AN ADMINISTRATIVE ORDINANCE VIOLATION FOR DRINKING IN PUBLIC. OFFENDER BECAME BELLIGERENT AND TOOK AN AGGRESSIVE APPROACH TOWARDS A/O WHILE SEATED IN HIS SQUAD CAR SHOUTING " YOU'RE A LIAR, FUCK YOUR MOTHER AND YOUR DEAD GRANDMOTHER, BLACK LIVES MATTER." A/O TOLD OFFENDER TO PLACE HIS HANDS BACK ON THE HOOD OF THE SQUAD CAR AT WHICH TIME OFFENDER FAILED TO COMPLY WITH A/O'S ORDERS. PO CHRABOT ATTEMPTED TO GAIN CONTROL OF OFFENDER BY GRABBING OFFENDERS LEFT ARM. OFFENDER THEN PULLED HIS ARM AWAY FROM A/O'S GRIP, TURNED IN A/O'S DIRECTION AND GRABBED A/O'S LEFT WRIST. PO CHRABOT IN FEAR OF BEING FURTHER BATTERED TOOK DOWN OFFENDER TO THE SIDEWALK. SUBJECT PLACED INTO CUSTODY AND TRANSPORTED TO THE 14TH DISTRICT. UPON ARRIVAL AT 14, OFFENDER REQUESTED AN AMBULANCE FOR RIGHT ARM PAIN.
