EVENT# 09677: IN SUMMARY: R/O'S ASSIGNED TO INVENTORY NARCOTICS FOUND ON TYLER LUMAR(OFFENDER) WHILE BEING ADMITTED TO COOK COUNTY JAIL. R/O RECEIVED THE FOLLWOING INFORMATION FROM CCDOC REGARDING THE INCIDENT. ON THE ABOVE DATE AT 0905HRS. DEPUTY WLODARSKI, T. STAR# 15733 WAS CONDUCTING A SEARCH OF NEW PRISONERS IN BULLPEN 23 WHEN DEPUTY WLODARSKI NOTICED PRISONER LUMAR, TYLER IR#2025878 REACHING BEHIND THE BULLPEN BENCH. DEPUTY WLODARSKI TOOK DETAINEES HAND FROM BACK OF BENCH AND SAW PRISONER DROP A PLASTIC PACKAGE. DEPUTY WLODARSKI RECOVERED THE PACKAGE WHICH CONTAINED 12 INDIVIDUALLY PACKAGED SMALL WHITE ROCKS (SUSPECT CRACK COCAINE) (INVENTORY #13750250). SGT LATHAM,C #3170 NOTIFIED, PRISONER AND CONTRABAND RETURNED TO C.P.D. DISTRICT 011 FOR CHARGES. TYLER LUMAR(OFFENDER) WAS TRANSPORTED BY CHICAGO POLICE CENTRAL DETENTION 5 TRANSPORT P.O.
