EVENT# 16321 IN SUMMARY, R/O'S ANSWERED A CALL OF AN AGGRAVATED VEHICULAR HIJACKING. UPON ARRIVAL R/O'S LEARNED FROM [REDACTED] (VICTIM AND COMPLAINANT) THAT WHILE PARKED IN FRONT OF ABOVE ADDRESS WITH VEHICLE RUNNING, VICTIM WAS APPROACHED BY UNKNOWN(OFFENDER) ANNOUNCING A ROBBERY AND STATED "BITCH GIVE ME THAT CAR" AT WHICH POINT OFFENDER POINTED A GUN AT VICTIM. UNKNOWN(OFFENDER#2) THEN APPEARED CARRYING A GUN AND JUMPED INTO THE DRIVER SEAT. VICTIM STATED SHE SAID "NO" AND THEN SCREAMED. OFFENDER#1 GRABBED VICTIM AND THREW HER TO THE GROUND. OFFENDER #2 THEN DROVE OFF IN THE VEHICLE S/B ON WALLACE. WHILE ON THE GROUND VICTIM SAW OFFENDER RUN TO AN AWAITING VEHICLE PARKED NEARBY. VICTIM UNABLE TO DETERMINE IF VEHICLE WAS OCCUPIED.
