(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

INCIDENT NARRATIVE

EVENT #01404. A/O'S OBSERVED LISTED VEHICLE TRAVELING S/B ON JEFFERY AND OVERTAKE A VEHICLE ON THE RIGHT AT 69TH ST. THE VEHICLE PROCEEDED S/B ON JEFFERY AND STOPPED AT THE RED LIGHT AT 71ST ST. WHEN THE LIGHT CHANGED TO GREEN THE VEHICLE ACCELERATED RAPIDLY FROM A STOP CAUSING THE TIRES TO SQUEAL AND AGAIN OVERTOOK A VEHICLE ON THE RIGHT CHANGING LANES WITHIN THE INTERSECTION ALSO FAILING TO SIGNAL LANE CHANGES. THE VEHICLE THEN PROCEEDED E/B ON 72ND ST AND THE VEHICLE AGAIN RAPIDLY ACCELERATED CAUSING THE TIRES TO SQUEAL. A/O'S ACTIVATED EMERGENCY EQUIPMENT AND THE VEHICLE FAILED TO PULL OVER. THE VEHICLE PROCEEDED E/B ON 72ND STREET AND THEN S/B IN THE EAST ALLEY OF MERRILL DISOBEYING A/O'S. THE VEHICLE CONTINUED S/B DOWN THE ALLEY AND THEN PULLED INTO AN OPEN GARAGE. A/O'S EXITED THEIR VEHICLE AND UPON APPROACH THE ARRESTEE QUICKLY EXITED HIS VEHICLE AND BEGAN YELLING AT A/O'S IN SLURRED SPEECH. A/O'S DETECTED A STRONG ODOR OF ALCOHOLIC BEVERAGE ON THE ARRESTEE'S BREATH AND THE ARRESTEE HAD GLASSY BLOODSHOT AND WATERY EYES. THE ARRESTEE THEN DISOBEYED DIRECT VERBAL COMMANDS BY A/O JONAS TO PLACE HIS HANDS ON THE VEHICLE. THE ARRESTEE THEN BALLED UP BOTH FISTS, SWUNG HIS ARMS, AND STRUCK A/O JONAS IN THE CHEST WITH HIS ELBOW AND ATTEMPTED TO PUSH PAST HIM. THE ARRESTEE THEN BALLED HIS FISTS AND PUFFED OUT HIS CHEST AND SAID "SHOOT ME" PLACING A/O'S IN FEAR OF RECEIVING A BATTERY. A/O'S ATTEMPTED TO PLACE THE ARRESTEE IN CUSTODY, AT WHICH POINT THE ARRESTEE DISOBEYED DIRECT VERBAL COMMANDS ATTEMPTING TO PULL AWAY BY SWINGING HIS ARMS AND TWISTING HIS BODY DURING WHICH THE ARRESTEE AGAIN STRUCK A/O JONAS ABOUT THE LEFT SIDE OF THE BODY. AFTER AN EMERGENCY TAKEDOWN THE ARRESTEE CONTINUED TO RESIST A/O'S BY KICKING HIS LEGS, TWISTING HIS BODY AND SWINGING HIS ARMS AT WHICH POINT THE ARRESTEE KICKED A/O POLSON IN THE LEFT LEG CAUSING INJURIES. DURING THE STRUGGLE A/O JONAS ALSO SUSTAINED INJURIES TO HIS RIGHT KNEE, AND LEFT HAND AND LEFT HIP. THE ARRESTEE ALSO SPIT ON A/O JONAS. BT 314 ARRIVED ON SCENE AND THE ARRESTEE KICKED A/O JUNG MULTIPLE TIMES IN THE LEGS CAUSING A/O JUNG TO FALL BACKWARDS AND SUSTAIN INJURIES TO HIS RIGHT ARM. WHILE ATTEMPTING TO PLACE THE ARRESTEE IN THE BACK OF THE SQUAD CAR THE ARRESTEE KICKED A/O POLSON IN THE LEFT ARM CAUSING INJURIES. THE ARRESTEE THEN LOCKED HIS ARMS AND CUFFED HANDS AROUND A/O JUNG'S LEFT FOREARM CAUSING ABRASIONS TO A/O JUNG'S ARM. THE ARRESTEE WAS TRANSPORTED TO 003 FOR PROCESSING AT WHICH POINT EMS WAS REQUESTED. THE ARRESTEE WAS TAKEN TO JACKSON PARK HOSPITAL. AT JACKSON PARK HOSPITAL THE ARRESTEE ATTEMPTED TO FIGHT WITH A/O'S AND HOSPITAL STAFF. THE WARNING TO MOTORIST WAS READ TO THE ARRESTEE AND THE ARRESTEE CONTINUED TO YELL OVER A/O'S. THE ARRESTEE REFUSED TO SUBMIT TO CHEMICAL TESTING. OPEN ALCOHOL WAS RECOVERED FROM THE VEHICLE, ONE 375ML BOTTLE OF BACARDI RUM AND STELLA ARTOIS BEER. BASED ON THE ARRESTEE'S DRIVING, A/O'S OBSERVATIONS OF THE ARRESTEE'S Demeanor AND THE ARRESTEE'S ACTIONS A/O'S BELIEVED THE ARRESTEE TO BE DRIVING WHILE UNDER THE INFLUENCE. THE ARRESTEE WAS TREATED AND RELEASED AT JACKSON PARK BY DR SZWAJKUN. MIRANDA RIGHTS READ IN 003. POST MIRANDA ARRESTEE STATED HE DRANK "A PINT OF HENNESSEY AND CRANBERRY JUICE." NO INVESTIGATIVE ALERTS, NO WARRANTS, NOT ON PAROLE. ET FOSTER #14410 BT 5823 PHOTOGRAPHED OFFICERS INJURIES, ET ORDERED TO PHOTOGRAPH ARRESTEE. DETECTIVE GOLZALEZ #20065 BT 5102 NOTIFIED.
