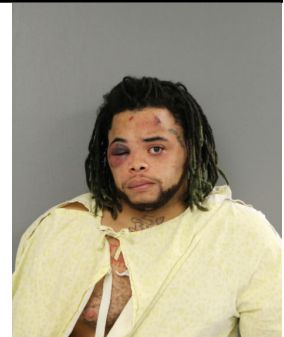

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

Event #16-279-05409. See also RD #HZ-461875 and Det. Div. Supp. reports. Above subject arrested in that during investigation of a traffic crash became agitated and would not follow verbal direction during a field interview. HUFF then became combative, would not follow directions and began walking away as well as flailing and swinging his arms. HUFF then struck P.O. MURILLO multiple times in the face and body and grabbed her hair slamming her head repeatedly into the ground refusing to let her go. During the struggle to stop HUFF's attack on P.O. MURILLO and place HUFF in custody P.O. MOUSSA was also repeatedly struck by HUFF. P.O.'s MURILLO, MOUSSA and WARNER were finally placed HUFF in custody and he was transported to Loretto Hosp. where he was treated by Dr. JOHNSON. R/O's also learned from Dr. JOHNSON that HUFF tested positive for PCP in his system. DUI kit was taken by RN MEDINA and turned over to P.O. THOMAS as evidence. HUFF is GIPP, TRAP, and LEADS clear. Arrestee has \$110.00 USC which was returned to him, HUFF's watch was inventoried under #13779828.
